Background

On March 27, 2020, Congress passed, and the President signed into law the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act provides \$30.75 billion nationwide in an Education Stabilization Fund to prevent, prepare for and respond to the coronavirus, of which:

\$13.2 billion is for the Elementary and Secondary School Emergency Relief Fund (ESSER) to support the ability of local educational agencies (LEAs), including charter schools that are LEAs, with emergency relief funds to address the impact that Novel Coronavirus Disease 2019 (COVID-19) has had, and continues to have, on elementary and secondary schools across the nation; and

\$2.95 billion is for the Governor's Emergency Education Relief Fund (GEER) which provides grants to Governors for the purpose of providing educational agencies with emergency assistance to address the impact of COVID-19.

Governor's Emergency Education Relief Fund (GEER)

New York State has been allocated \$164.2 million under the Governor's Emergency Education Relief Fund (GEER). The entirety of New York State's GEER funds were programmed in the 2020-21 enacted New York State budget through the application of a "pandemic adjustment" to partially offset the state share of state aid to school districts. Pursuant to the direction of the Governor's Office and the Division of the Budget, GEER funding is being allocated to the State's 673 major school districts. GEER funds are not being allocated to LEAs that are charter schools, Special Act School Districts, or school districts employing fewer than eight teachers. These funds will be allocated to eligible school districts using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent fiscal year (2019-20).

Elementary and Secondary School Emergency Relief Fund (ESSER)

New York State has been allocated \$1.037 billion under the Elementary and Secondary School Emergency Relief Fund (ESSER). ESSER funds to school districts were programmed in the 2020-21 enacted New York State budget through the application of a "pandemic adjustment" to partially offset the state share of state aid to school districts. ESSER funding is being allocated all LEAs, including charter schools and Special Act School Districts, that received 2019-20 Title I, Part A subgrants. Pursuant to the terms of the CARES Act, Local Educational Agency (LEA) allocations were calculated using the relative shares of grants awarded under Title I, Part A of the Elementary and Secondary Education Act (ESEA) for the most recent fiscal year (2019-20).

The Croton-Harmon Union Free School District comprises three school buildings. There is one primary--Carrie E. Tompkins Elementary (K-4), one middle school--Pierre Van Cortlandt Middle School, and one high school--Croton-Harmon High School.

In response to the COVID-19 pandemic, The Croton-Harmon School District, along with other districts in the State of New York, was ordered to close in-person instruction in mid-March 2020. The closure order ultimately extended through the end of the school year. The District developed a remote learning program to complete the 2019-20 instructional school year and spent summer 2020 developing several learning models (in-person, hybrid and remote) to ensure staff and student safety, while also providing instructional flexibility for the 2020-21 school year. In order to meet this immediate and ongoing requirement, the District will need to purchase various devices, supplies, and materials to facilitate and meet instructional standards for all students. This budget was developed to support our ability to continue to provide educational services to students and to enhance the ongoing functionality of our instructional programs. The budget consists of teaching tools and classroom technology supports that include docking stations and headsets for teachers to provide remote and in-person instruction.

The Croton Harmon school district maintains on-going cohort assessment data in order to assess student growth. The district utilizes a standards based local assessment for both math and English language arts. Academic Intervention Services (AIS), Response to Intervention Services (RtI), Learning Centers, and special education services are provided to those in need of academic support. All of these services are monitored through data collection. Additionally, social emotional needs are assessed through surveys, norm referenced assessments, and building level at-risk committees. The district continues to plan for and provide summer supports and remedial programs to address learning gaps. Compensatory services will be provided as determined through assessments for students with IEPs who have missed services due to the COVID 19 pandemic.

The Croton-Harmon Union Free School District comprises three school buildings. There is one primary--Carrie E. Tompkins Elementary (K-4), one middle school--Pierre Van Cortlandt Middle School, and one high school--Croton-Harmon High School.

In response to the COVID-19 pandemic, The Croton-Harmon School District, along with other districts in the State of New York, was ordered to close in-person instruction in mid-March 2020. The closure order ultimately extended through the end of the school year. The District developed a remote learning program to complete the 2019-20 instructional school year and spent summer 2020 developing several learning models (in-person, hybrid and remote) to ensure staff and student safety, while also providing instructional flexibility for the 2020-21 school year. In order to meet this immediate and ongoing requirement, the District will need to purchase extensive supplies and materials to facilitate the re-entry of staff and students and meet instructional standards for all students.

This budget was developed to support our ability to continue to provide educational services to students and to enhance the ongoing functionality of our instructional programs. The budget consists primarily of personal protective equipment (PPE) and specific facility enhancements needed for safe re-entry in September. These items consist of masks; sanitizing wipes, cleansers, and dispensers; protective face coverings; Merv filters (as prescribed and recommended by the CDC and Governor's Executive Order. Additionally, with regard to our Food Service, we have purchased additional devices to support the safe and touchless distribution of school lunches to our in-person and remote learners.

- 2. Does the LEA intend to use ESSER funds to promote or support remote learning?**

No, the LEA does not intend to use ESSER funds to promote remote learning.

- 3. In the space below, please describe how the LEA intends to assess and address student learning gaps resulting from the disruption in educational services (150 words or less).**

The Croton Harmon school district maintains on-going cohort assessment data in order to assess student growth. The district utilizes a standards based local assessment for both math and English language arts. Academic Intervention Services (AIS), Response to Intervention Services (RtI), Learning Centers, and special education services are provided to those in need of academics support. All of these services are monitored through data collection. Additionally, social emotional needs are assessed through surveys, norm referenced assessments, and building level at-risk committees. The district continues to plan for and provide summer support and remediation to address learning gaps. Compensatory services will be provided as determined through assessments for students with IEPs who have missed services due to the COVID 19 pandemic.
