We are trying to stop the video from circulating in our school buildings. If your child shares with you that they have seen this content, please let your building principal know. We have resources and support personnel available to assist students. In addition, please make sure your child(ren) is aware that if they are involved in sharing inappropriate material, whether through text or social media, they could face consequences issued by the school or possibly law enforcement.

Please know that we are taking this issue very seriously and that the safety and security of students is the District's priority. We appreciate everyone's cooperation in keeping our children safe.
