Part I. GENERAL EXPECTATIONS AND OBJECTIVES

Kettering City School District agrees to implement the following statutory requirements:

- A. **Involve parents and family members** in jointly developing the local education agency's Title I, Part A plan under section 1112 and the development of school support and improvement plans under section 1111(d).
- B. **Provide the coordination, technical assistance and other support necessary** to assist and build the capacity of all participating schools within Kettering City Schools in planning and implementing effective parent and family engagement activities. These activities must improve student achievement and school performance, which may include meaningful consultation with employers, business leaders, philanthropic organizations or individuals with expertise in effectively engaging parents and family members in education.
- C. **Coordinate and integrate** parent and family engagement strategies, to the extent feasible and appropriate, with other relevant federal, state, and local laws and programs.
- D. **Conduct** with meaningful involvement of parents and family members, an annual evaluation of the content and effectiveness of the parent and family engagement plan in improving the academic quality of all schools served under this part, including identifying:
 - Barriers to greater participation by parent/families in activities authorized by this section, with particular attention to parents with:
 - Economic disadvantages;
 - Disabilities;
 - Limited English proficiency;
 - Limited literacy; or
 - Any racial or ethnic minority background;

- The needs of parents and family members to assist with the learning of their children, including engaging with school personnel and teachers; and
- Strategies to support successful school and family interactions.

E. Use the findings of such evaluation to design evidence-based strategies for more effective parental and family engagement, and to revise, if necessary, the parent and family engagement plans described in this section.

F. Involve parents in the activities of the schools, which may include establishing a parent advisory board comprised of a sufficient number and representative group or family members served by [redacted] Kettering City Schools [redacted] to adequately represent the needs of the population. This advisory board will help develop, revise and review the parent and family engagement policy.
