

**PARENT CONSENT & RELEASE**  
*TRY UNISUS PROGRAM 2023*

**PROGRAM**

- I have read and understood the Unisus Code of Conduct and Informed Consent Guidelines.
- I give permission to my child to participate in all program activities that happen on or outside of UNISUS campus, for the purpose of enhancing academic, cultural, social, and physical development and understand that some may involve various levels of risk.
- I understand that transportation to and from Summerland, British Columbia, will be provided by bus or any other school-issued vehicle. I give permission for my child to travel in a school-issued vehicle driven by an UNISUS appointed personnel.

**PHYSICAL ACTIVITY AND HEALTH**

- I give permission for my child to participate in organized physical activities. If my child has a physical condition that limits participation, I will provide a Doctor's medical certificate at the time of registration. I understand that these activities may involve various levels of risk.
- I give permission for my child to receive prescribed (including epi-pens) or over-the-counter medications if my child is ill.
- I give permission to seek medical attention for my child from a medical practitioner and/or to call an ambulance in case of an emergency.
- Parental consent is required for the distribution of any sensitive personal medical information. If parental consent is not given, the student's activities may be limited. I give consent to release full or partial sensitive personal medical information.
- I understand the risks associated with the program activities and hereby assume these risks, knowing them, giving my child permission to participate. I understand Unisus School is not liable for any injuries or other occurrences due to indoor and outdoor activities or related risks, and/or the actions or omissions of Unisus School counselors, educators, organizers, employees, or any other entities being released.

**PRIVACY AND TECHNOLOGY**

- We have read and understood the Privacy Disclosure.
- We give permission for images of my child to be used for educational and marketing purposes by Unisus in digital, print, video, or still media.
- We understand that lockers and all student-used spaces physical and digital are owned by Unisus and may be entered/searched if needed.

The School assumes, unless instructed otherwise by parents, that use as described above, and similar use of images and recordings for School-related purposes is an acceptable practice that does not require explicit parental consent, other than the one given in this form. **RISK**

**PARENT RELEASE**

This Release shall be exclusively governed by British Columbia law without regard to choice-of-law principles. Any dispute concerning the Presentation and/or Supporting Information, or arising out of or relating to this Release, shall be resolved in the courts of the Province of British Columbia.

In consideration of my application and permitting my child to participate in the Try Unisus Program 2023, I hereby:

WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the Unisus School and all of its affiliated legal entities, its trustees, employees, counselors, volunteers, and any other persons released, for my child’s personal injury, disability, property damage, property theft, or actions of any kind which may hereafter occur to them including their traveling to and from activities;

INDEMNIFY AND HOLD HARMLESS the Unisus School and all its affiliated legal entities, its trustees, employees, camp counselors, volunteers, or any other entities or persons released from any and all liabilities or claims made as a result of participation in the Try Unisus Program 2023, whether caused by negligence of release or otherwise.
