**Statement Of Purpose**

**Kennedale Junior High** is dedicated to the success of all students. The faculty and staff believe in the importance of having our families as vital partners in the education of their children. At school, we believe that parent involvement is essential to the success of our children and welcome the opportunity to work toward establishing a working relationship with our families.

As a campus, we are committed to:

- Respecting parents as partners in the education of their children and honoring their role as first and lifelong teachers, increasing the capacity of our school personnel to work in partnership with their families
- Expecting high academic achievements for all students
- Promoting family involvement through site-based leadership and partnered decision-making
- Fostering a welcoming and responsive environment for all family members
- Establishing and promoting open communication as a source of information and trust between the school staff and families
- Providing the means, whenever possible, for the participation of families with barriers to participation that include, but not limited to, limited English proficiency, disabilities, or migratory status
- Informing families if their children have been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title 1 Final Regulations (67 Fed.Reg.71710, December 2, 2002)

Parent Involvement means the participation of family members in regular, two-way and meaningful communication involving student academic learning and other school activities, including ensuring:

- (B) that families are encouraged to be actively involved in their child's education at school

Families will be informed about the meetings by email, school website, blackboard messages, newsletters, and/or notices sent home with students.

### **School-Parent Compact**

**Kennedale Junior High** will work with families, campus faculty, and campus administration to annually develop, review, and revise the school-parent compact. - annually use survey results, and other resources as baseline data for the upcoming year (Analysis used in making changes may vary from year to year);
- establish a family engagement goal for the upcoming year;
- develop and implement strategies to increase family involvement based on evaluation results
