Admission Policy

The Brownsville Early College High School (ECHS) follows the stand-alone school model. For admissions, students are chosen through a weighted lottery that favors students who are at risk or who are part of the targeted subpopulations for the ECHS model. Specifically, students who complete all required paperwork to be part of the ECHS 9th grade cohort are then given an Early College High School Commitment/Application where all relevant PEIMS data is pre-slugged based on the district's data base. Once the Commitment Form is returned to the home ECHS campus, all students who returned the form will go into the lottery one time. A student will go into the lottery an additional time for each of the following identified PEIMS measures: At-Risk, Hispanic, economically disadvantaged. Therefore, a student's name can go into the lottery anywhere from one to four times depending on the PEIMS indicators.

BECHS Entrance Requirements

- Students must be in the 8th grade and be promoted to the 9th grade.
- Students must be in good academic standing.
- Students must complete an application packet.
- Students must meet expectations on the required mandated state assessments.
- Students must meet Compulsory Attendance Law.
- Students must commit to a summer bridge program.

Brownsville Early College High School Student-Parent Contract

As long as I am a Brownsville Early College High School (BECHS) student and attend UTRGV the Student-Parent Contract requirements remain in effect. The requirements are listed below but not restricted to the following:

- I understand as long as I am a BECHS student and attend BECHS/UTRGV I will adhere to maintaining a demeanor and appearance that is of a professional standard on and off campus.
- I understand I am expected to achieve and maintain exemplary academic status each marking period.
- I understand that BECHS has 9th and 10th grade teachers on the High School campus. The 11th and 12th grade teachers are UTRGV professors and all students are expected to attend college classes at UTRGV.
- I understand it is imperative that I pass the TSI test as early as possible so I will be admitted to UTRGV my 11th and 12th grade year. If I have not passed the TSI test as early as sophomore year, before registration deadline for FALL of the following school year, I will be required to return to my home campus.
- I understand as long as I am a BECHS student I will abide by all rules listed in the BISD Student Code of Conduct.
- I understand that if I fail to maintain high academic standards at BECHS I will be placed on an Academic Intervention Plan and face possible removal to home zoned campus.
- I understand if I fail more classes than what summer school has to offer I will be required to return to my home campus.
- I understand that BECHS does not offer 11th and 12th grade regular high school classes and if I am not in compliance with UTRGV standards (such as; GPA drops below a 2.0: violation of the rules; excessive absenteeism) I will be required to return to my home campus.
- I understand if I am in violation of the Student Code of Conduct and I am sent to the Brownsville Academic Campus (BAC) this action will be immediate grounds for removal from BECHS and back to home campus.
- I will attend all my classes on time and not have excessive absences. I understand I cannot lose credit for any of my classes due to absences
- I will be required to replace lost or destroyed property, including textbooks.
