He felt there was also a good turnout for the Pre-School Screening. Kindergarten Round Up is going to be Monday, March 22nd. 46 letters were sent out for that. The dates for the elementary Concert will be May 6th beginning at 6:15 for the first set and approximately 7:15 for the second set. The concert for the Grandparents will be held on May 7th at 1:30. The end of the third quarter is coming up on April 1st. There will be a visiting poet coming to the elementary on April 23rd. Mrs. Gingles, the School Readiness teacher has mentioned having all day pre-school, 2 days per week. She has sent out parent

to get an idea how the parents feel about that idea.

Mr. Ulrich stated what an outstanding season was had by all of our winter sports! There will be an Awards Night for the winter sports on Tuesday, March 30th. Spring sports have all started. He wanted to make sure to give a big Thank You to all of the people who work at our sporting events, from concessions, to ticket

takers to officiating and beyond. Thanks for all of your time and effort!

- **5. High School Report** Mr. Griepentrog mentioned that spring play auditions are coming up. The spring play this year will be Agatha Christy's, "And Then There Were None". The Haitian Relief Fund is still working to raise \$500. The High School concert will be Tuesday, May 11th at 7:00. The High School Winter Concert/Fine Arts Night was well done! The MCA Leadership Committee has been working to Prepare for the upcoming MCA's. Parent/Teacher conferences had the best attendance ever! Mr. Griepentrog relayed the outcome of the research he's done with past students and also some colleges, to find out if they feel Minneota Public Schools prepared them well for life after high school.
