- 4. Elementary Report by Mr. Ulrich: The Elementary Spring Concert and Grandparent's Day were held on March 23 and 24 and went well and had good attendance. On April 11 Jill Kalz was here as our visiting author. She visited with each class. MCA testing will be finishing up in the next couple of weeks. Elementary field trips will be taking place from now until the end of the school year.
- **5.** AD Report by Mr. Ulrich: Spring sports are well underway. The rewards cards have been sold and we are starting to see the money come in from them.
- 6. High School Report by Mr. Griepentrog: The FFA general livestock judging team, the dairy judging team, and mechanics teams are all competing at the State level. The Robotics team received the Coopertition Award at the first robotics competition at the Minnesota North Star Regional Event. Speech has one individual who placed in sections. The coaches have done a great job! Scheduling for next year is now in progress and almost finished. Congratulations to the Culinary Skills team of Cal Swedzinski, David Cayetano, Natalie Prescher, and Brandon Ashbach for their first place finish in their competition. Congratulations to Shay Buysse for her second place finish in the regional photography contest sponsored through SW/WC media graphics. NWEA testing will begin in a couple of weeks for grades 7-11. The Seniors are planning a Senior trip to Sioux Falls. Prom will be held on April 28. Graduation will be held on May 12 at 2:00 p.m. We received the EF (Educational Foundation) Global Education Excellence

- Award for 2011-12 for our continued flexibility and participation in the foreign exchange student program. We also welcomed a foreign exchange student from Spain to finish out the school year.
