- 1. The Budget Summary and Receipt Listing Report were reviewed.
- 2. The High School Activity account was reviewed.
- 3. K-12 Principal and A. D. Report by Mr. Ulrich: Summer school has started and we have 12 students attending ranging from ECSE to Elementary age. The cleaning is coming along well. The new computers are here. The old computers have been removed from the south lab and the new ones have been installed. New teachers will have a workshop day on August 13. Inservice for all teachers will begin that week too. Mr. Ulrich went on a tour sponsored by Farm Bureau to three different farms. It was an amazing tour and he has a whole new appreciation for what our farmers do. Fall sports practices will begin on August 13. Dollars For Scholars will be holding their golf tournament on July 28. The rewards cards have brought in \$2664.30 since we started the program.
- 4. Superintendent's Report by Mr. Deitte: Mr. Deitte attended the superintendent's conference in Alexandria. It was very good and centered mostly on technology. There were 40-45 superintendents there from three different service co-ops. Mr. Deitte will be attending the MSBA Summer Seminar on August 6 and the Welcome Back sponsored by the MDE on August 7 and 8. Q-Comp training will be August 8. Dollars For Scholars has been doing a good job on getting prizes and donations and we're thankful for that. Mr. Deitte met with Chris Swedzinski to talk about where we're at as a district as well as where we are as a state. Mr. Deitte has also met with the new part-time police officers to give them contact information for the school. We have been reviewing and working with the testing data but are unable to share the results until August because they have been embargoed by the state. Our Title I allocations were 20% less this year which has caused us to decrease our title position from 100% to 68%. The fitness center doors have been fixed, the toilets are being replaced, the ITV room has new carpeting and is getting set

up, the cement by the elementary sidewalk has been poured, and the roofing project is in progress. The audit will begin the 1<sup>st</sup> week of August. New teachers will begin workshop on August 13 and all teachers will report on August 14. August 14 will be Q-comp training with all teachers being here for half of the day and the Q-Comp council meeting for the whole day, August 15 will be a work day, August 16 there will be a workshop in Marshall and August 17 will be a workshop in Pipestone. July 31 Mr. Deitte will be in Mountain Lake working on the second FLY application. We have had a lot of turnover in staff and Harlen has done a nice job of getting quality people in to replace those leaving. Congratulations to the FCCLA at the national competition. Mr. Griepentrog has taken a job in Maple River. We wish him well in his new position. The integration budget was approved at \$46,561.20.
