- 1. The Receipt Listing Report and the Budget Summary Report were reviewed. We will be revising the budget after Christmas and will adjust some areas that are over or under the original budget.
- 2. The High School Activity account was reviewed.
- **3.** Supt. Deitte updated the enrollment, with the current number being 442. A report with projected Kindergarten estimates was also reviewed.
- 4. K-12 Principal/AD Report: The High School has started a new program called GPO. It is in place of ZAP. It gives students three opportunities to get homework done throughout the day. The elementary celebrated Red Ribbon Week in October. On October 23<sup>rd</sup> the Juniors attended a college fair at SMSU. We had a mock election at the school on Election Day. It went very well and Kristi Liljenquist did a good job putting it together. We held a Veteran's Day program on November 12<sup>th</sup>. The students did a fantastic job. The elementary students had a lyceum last week on Motivation. It was a very good presentation. The high school musical was well attended. The Elementary Christmas Program will be held on December 6<sup>th</sup> at 6:30 p.m. and the High School Christmas Program will be held on December 13<sup>th</sup> at 7:00 p.m. The MCA tests have changed this year. You will be able to take 2 practice tests on the computer and one final test. We will be taking the final test on paper instead of a computer. The fall sports have wrapped up. Amanda Grengs placed 25<sup>th</sup> at the state Girls Cross Country Meet. The Football team was runner-up in the section and finished the season with a 9-2

- record. The Volleyball placed 3<sup>rd</sup> at the State Tournament. Three girls made the All-State team and Megan Larson and Taylor Reiss made the All-Tournament team. Dance Team has been going for a month and both Basketball teams and the Wrestling team have started practice. The Camden Conference has decided to waive all dues this year.
- 5. Superintendents Report by Supt. Deitte: Congratulations to the fall sports and all of the students in the musical! There were a lot of good reviews and very good attendance. MEMO did a fundraiser at intermission to raise money for scholarships. They also did a breakfast for all of the staff during American Education Week. Congratulations to Dan Longtin, Christy Brewers, and Bernie DeCock for winning the school board election. Supt. Deitte went to SMSU to talk with people from Thailand. They wanted to learn more about American schools. We are getting close to having the Continuous Improvement Plan complete. The Race to the Top grant application was submitted. 379 total applications were submitted nationwide, with 5 being from Minnesota. 170 of the applications were from Texas or California. Supt. Deitte will also be helping with the process of hiring a new City Administrator. Stephanie Hennen and Supt. Deitte will be working on a Community Education survey. They are going to try to get a computer class going and look to see what other people may be interested in. Defensive Driving was held here in October. We are looking for ideas to get the community involved.
- **6.** MREA Report by Supt. Deitte: Supt. Deitte, Christy Brewers, and Dawn Van Keulen attended the MREA Conference last week. There was not a high cost to the conference and it was very good. They attended different sessions and platforms were adopted at the conference.
