III. Reports

- **1.** The Budget Summary and Receipt Listing Report were reviewed. We have added some additional unbudgeted expenses for the 2014-2015 budget.
- 2. The Enrollment Report was reviewed. The current enrollment is 544.
- **3.** The High School Activity Report was reviewed. All of the balances are doing well, although there weren't many expenses in August since it was the start of the school year.
- 4. Michael Bliss, a High School Math Teacher, brought in devices and showed the school board how he uses technology in his classroom. He specifically presented the program Nearpod.
- **5.** K-12 Report by Mr. Frie: The 1st annual career fair will be held during conferences! The sound system is installed and sounds great! Mr. Frie is very impressed with the sound of the microphones. The new academic eligibility policy is working well. We have only 7 students that are ineligible in the high school. The Q Comp Council has selected two books that the staff will be reading this year. Also, the Sophomores will be receiving their devices next Wednesday!
- 6. AD Report by Mr. Myhre: Fall activities are in full swing. The Volleyball Team is 12-5, and the Football Team is 3-0. Football will be in Class A, Section 3 this year. We were moved to the southern section when we got put into Class A. The #1 team will get a bye first round of playoffs since there is only 7 teams in this section. The Cross Country Team is doing well this year. They will be traveling to Milaca this weekend. The Volleyball Team will be hosting a 9th grade tournament at home this weekend. The Sidekickers will be dancing at half time of the Football Game on Friday night. We are working on re-establishing Mock Trial this year. Mr. Myhre attended an A.D.'s workshop and learned a lot about what needs to be done at the beginning of the year. It was very helpful. The fencing at the new baseball field is complete. Thank you to Larry for getting everything lined up for the ball field.

- 7. Superintendents Report by Mr. Deitte: We are working hard on getting the teacher's Smart Goals complete. The Q Comp Council will meet on Monday to review the goals for each teacher. We are excited about the test results! We got the teachers together when they were released to share the data and celebrate! The Woman of Today will be hosting a School Board Candidate Forum on October 6th. The Ivanhoe transition is going well. The weather will be something new to deal with in the winter. Homecoming will be held September 29th through October 3rd. Thank you to Meredith Sander and Amber Rodas for planning all of the activities!
- 8. MCA Testing Results by Jen Mahan-Deitte: The testing results were very positive this year! Jen reviewed the different areas that are tested and the growth that we had in each area. She also broke the data into sub-groups of students, like Free/Reduced Lunch, Special Ed, and English Learners. The District increased the MCA Math score by 8%, the MCA Reading score increased by 12%, and the MCA Science score increased by 16%!
- 9. Fitness Center Committee Report by Mr. Deitte: Mr. Deitte reviewed what took place at the first Fitness Center Committee meeting. The committee will be putting out a survey to members for feedback on what is needed. They plan to meet again on November 12th.
