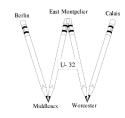

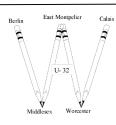
WCUUSD Board Norms - Adopted November 18, 2020

- **Public input** –Notify the community about public forums and opportunities for public comment at board meetings.
- Community involvement during regular meetings of the board Every meeting will include at least one opportunity for public comment. Public comment is an opportunity for board members to listen and ask clarifying questions. If a board member feels a concern raised in public comment warrants further board discussion, they may request that the issue be added to a future agenda.
- **Community dialogue** The board may periodically schedule community forums that allow for dialogue, questions and answers from the board or the district leadership team.
- Stay on time Start and end on time. The chair may appoint a time-keeper.
- All voices will be heard Every board member gets a chance to speak. Some topics warrant having each board member speak in turn to ensure full representation.
- **Reflection** –To allow time for reflection, the chair and agenda steering committee will plan time for complex or contentious issues to be discussed at more than one meeting before the board votes, except where a decision is urgent.
- Announcements in reports Announcements from the administration will appear in the reports and not as discussion items.
- Role of the board At the end of each board meeting reflect on whether the board remained focused on its policy-making and oversight role during the meeting, rather than operational details that are the responsibility of leadership team.
- **Respect each other** Listen, allow others to be heard, share concerns, assume positive intentions, be present, celebrate successes.

WCUUSD Finance Committee Meeting Minutes 10.10.23 8:30-9:30 AM Virtual

Present: Flor Diaz Smith, Meagan Roy, Ursula Stanley, Kari Bradley, Susanne Gann, Dan Keeney, Zach Sullivan

- 1. Call to Order: Flor Diaz Smith called the meeting to order at 8:31 a.m.
- 2. Approve Minutes of 9.20.23: Kari Bradley motioned to approve the minutes from 9.20.23. Ursula seconded and the motion passed.
- 3. Informational Reports
 - 3.1. Monthly Reflections: Susanne provided a memo highlighting some of the activities in the finance department over the last month. These highlights include reports for Act 173 Special Education Plan that get submitted to the AOE, grant close-out reports submitted to the AOE, an update on Frontline Time and Attendance and some new functionalities in regards to FMLA, and hours worked by support staff to report to the Vermont Municipal Employee Retirement System (VMERS). Tom has been working on fixed assets to reflect all assets added or deleted in FY 22-23. Penny has set up the NEMRC Accounts Receivable module which allows billing from that system. Also reported on the intent to explore a Food service management company service delivery model.

4. Discussion/Action

- 4.1. FY 25 Capital Improvement Project Budget Update and Approval: A memo was provided in regards to the FY 25 Capital Improvement Project Budget Update which gave a rough estimate of \$1,301,000. These estimates were developed in 2019 so an inflation estimate of \$60,300 was included for a total amount of \$1,361,300. After the completion of scope and budget on several projects the updated estimated total cost including contingency and soft costs =\$1,488,802. This amount is within the current amount reserved in the Capital Improvement Fund Balance through FY 2024-25. Ursula motioned to recommend that the Board authorize the allocation of \$127,502 additional capital reserve funds to the completion of the projects as identified and approve the District moving forward with the bid document and bidding as necessary. Kari seconded. There was some discussion. The motion passed
- 4.2. Award U-32 Exterior Door Replacement Bid: Daniel recommended that the Board approve awarding the U-32 Exterior Door Replacement project to Acme Glass, Inc. in an amount not to exceed \$117,254 to be completed in FY 23-24. Zach seconded. There was some discussion. The motion passed.

- 4.3. Review and Approve FY 25 Dental Premiums: Ursula motioned that the board set the calendar year 2024 Dental Insurance premiums as follows: Single Plan: \$720; 2 Person Plan \$1080; Family Plan \$1680. Zach seconded. Kari asked why a steep increase in premium. Susanne advised an increase in claims is the driver due to a trend. Daniel abstained from the vote. The motion passed.
- **4.4.** Advise on School Board Budget Training: Meagan spoke about the training coming up and the plan for what that will look like. She advised they will have a baseline budget to start with, what the budget looks like now and in November they will have an actual recommended budget which is a little different than last year. She spoke about the potential for a budget committee comprised of faculty and staff. There was some discussion surrounding the budget process and ideas of what should be included.
- **4.5. Budgeting Process Community Message:** Kari put together a draft timeline of how/when the budget information will be communicated to the communities. Daniel suggested calling it the current budget climate as opposed to a budget draft and then in November have a budget recommendation. There was a discussion about the language to be used and the role of the board.

6. Adjourn: The meeting was adjourned by consensus.

Data Mining Protocol

Adapted from <u>CLEE's Data Mining Protocol</u>, developed in the field by Thomas Van Soelen and Shannon N. Kersey.

- 1. **Getting started:** the facilitator reminds the group of norms and shares each step outlined below.
- 2. Examining data set #1: Examine data set #1 (1 minute)
- Describing data set #1: The facilitator asks, "What do you see?" In rounds, participants offer statements about the data, avoiding judgments and interpretations, using directionality words wherever possible (e.g., "on page 2, I see," "in the third column, I see"). (7 minutes)
- 4. **Interpreting data set #1:** The facilitator asks, "What wonderings do you have about the data?" In rounds, participants offer "I wonder statements." (7 minutes)
- 5. Examining data set #2: Examine data set #1 (1 minute)
- Describing data set #2: The facilitator asks, "What do you see?" In rounds, participants offer statements about the data, avoiding judgments and interpretations, using directionality words wherever possible (e.g., "on page 2, I see," "in the third column, I see"). (7 minutes)
- 7. Interpreting data set #2: The facilitator asks, "What wonderings do you have about the data?" In rounds, participants offer "I wonder statements." (7 minutes)
- 8. Examining data set #3: Examine data set #1 (1 minute)
- Describing data set #3: The facilitator asks, "What do you see?" In rounds, participants offer statements about the data, avoiding judgments and interpretations, using directionality words wherever possible (e.g., "on page 2, I see," "in the third column, I see"). (3 minutes)
- 10. **Interpreting data set #3:** The facilitator asks, "What wonderings do you have about the data?" In rounds, participants offer "I wonder statements." (4 minutes)
- 11. **Identifying Intersections and Dissonances:** The facilitator offers time for the group to talk together about what intersections are evident in the data and what dissonances arise from the data. (10 minutes)
- 12. Debrief (5 minutes)

NESDEC - District

Each year, the district provides enrollment data to the New England School Development Consortium (NESDEC). Using this data, NESDEC adjusts their calculations in real time to account for births, retention rates and migration rates. All of this information together is used to calculate their projections. NESDEC projections are historically accurate over time and are used by many school districts in Vermont. It's important to note that these numbers <u>do not</u> include students who attend U-32 via school choice, tuition or our MOU.

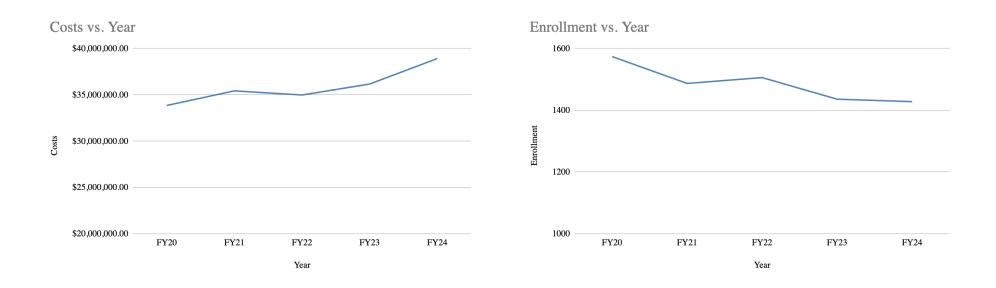
