**Background:** For background information on the eLearning Program in Gower, the following reports are recommended to be reviewed/downloaded:

- [Recommendation for eLearning Days in Place of Emergency Days, 12-18-18](#)
  - Presented initial eLearning plan to be used district-wide for Board approval
  - Provides useful background information regarding the new flexibility granted to local school districts related to the definition of an instructional day and the subsequent plan implemented in Gower.
  - Emphasizes the ‘e’ in an eLearning Day represents ‘engagement’ more so than ‘electronic’ given the state-level guidance around building a definition of ‘an instructional day’ and to establish clear expectations around ‘student attendance’
    - Recommendation approved by Board by a vote of 7-0 in favor of plan
  - Plan submitted to Sen. Curran, member of the Senate Education Committee Jan 31, 2019 along with recommendation for possible amendment to [Senate Bill 28](#)
- [eLearning Plan Update, 2-19-19](#)
  - Presented to Board for feedback and revision
  - Included attendance data, student, staff, and parent feedback for the eLearning Days used in Gower on Mon., Jan. 21, 2019; Mon., Jan. 28, 2019; Wed., Jan. 29, 2019; and Thurs. Jan 30., 2019
    - The variance in student attendance data on eLearning days and regularly scheduled school was 4.5% after analyzing attendance data for Jan. 21 as well as the week of Jan. 28-Feb. 2 indicating a fair amount of consistency; particularly when considering that engagement is required for attendance on eLearning days
    - An early analysis of the parent feedback collected after the second eLearning day held on Jan. 28, 2019 indicates that feedback coded as ‘generally positive’ outnumbered feedback coded as ‘generally negative’ at a ratio of roughly 4:1 among the sampling of 60+ individual parent comments.
    - An early analysis of the student feedback collected after the second eLearning day held on Jan. 28, 2019 indicates that feedback coded as ‘generally positive’ outnumbered feedback coded as ‘generally negative’ at a ratio of roughly 6:1 among the sampling of 120+ individual parent comments.
  - Included “key takeaways/points for consideration” for plan modification
- [eLearning Program Update, 3-19-19](#)
  - Provided an update on the current legislation (Senate Bill 28) that was passed by the Senate Education Committee (3/12/19)
  - Provided details related to the formal process to approve/adopt an eLearning Program in a local school district (as anticipated by current legislation)
  - Provided details from the Gower eLearning plan to account for provisions to be verified by the regional office of education for the school district as part of the formal approval process

**Current State:**

Since the March. 19, 2019 eLearning Plan Update provided to the Board of Education, Senate Bill 28 continues to move through the State legislature and is expected to pass after the Capitol recess period and is also expected to be signed by the Governor to become law in expedited fashion. The bill was passed by the Senate and is currently in the to be approved in the Senate as well as the House in the coming weeks prior to becoming law.

According to the amendment expected to become statute this spring, a school board may, by resolution, adopt a program for e-learning days district-wide that shall permit student instruction to be received electronically while students are not physically present in lieu of the district's scheduled emergency days. Before its adoption, the school board must hold a public hearing on the proposal for an e-learning program at a regular or special meeting of the school board, in which the terms of the proposal must be substantially presented and an opportunity for allowing public comments must be provided. Notice of such public hearing must be provided at least 10 days prior to the hearing by:

District officials have maintained communication with officials from the DuPage Regional Office of Education and have shared all local eLearning materials for review and have requested a timely review pending the outcome of the proposed Board Resolution to adopt the eLearning program as recommended. A representative from the DuPage Regional Office of Education has acknowledged the request. It is expected that the regional office of education for the school district will be required to verify that local proposals for e-learning programs have met the requirements specified and that such proposals contain provisions designed to reasonably and practicably accomplish these specifications. The local eLearning plan developed in Gower provides for such specifications (italicized print below) as follows and as previously reported:

- Per [Recommendation for eLearning Days, 12-18-18](#): Our commitment to being a [FutureReady](#) school district was made clear through Board action in Sept. 2014 as well as through the implementation of our [i3 Learning Initiative](#) designed in 2013 which continue to impact our Teaching and Learning model to this day. It is clear that our district has the infrastructure and professional capacity in place to support the adoption of eLearning days in place of traditional emergency days. A recent Home Connectivity Survey indicates that 98.4% of our students have access to reliable internet service at home based on a current return or direct contact rate of 100% at GM and 98.8% of our students have access to reliable internet service at home based on a current return or direct contact rate of 85% at GW. Measured in single digits at each school campuses, school staff will work with individual families to accommodate as needed (e.g. Loaner WiFi ‘Hot Spot’, Access to Reduced Rate Programs, Direct Financial Assistance, etc.).

  - If my child has a question about an assignment, what do we do?
    - Teachers and specialists will be available for support from 8:30 am to 1:30 pm
  - Parents/students can email their teacher/specialist, do a virtual chat with their teacher, post a discussion question in Schoology, or call and leave a voicemail
    - Teachers can retrieve school voicemails remotely.
  - What If there is a power outage within the community on the emergency day?
    - The District would likely adjust the due date for the eLearning Modules if needed and adjust attendance accordingly.

    - Completion of 3 of the 3 eLearning Modules will be recorded as a full day

  - Gower School District officials contacted the co-presidents of the Gower Educators Association (GEA; Teacher Union) on Nov. 27 to begin the discussion provided the potential for a change to our current practice. With a clear consensus to investigate further, and ongoing communication and agreement, the GEA and Gower Admin Team met on Dec. 10 to build a framework for ‘E-Learning Days’ in Gower to share with staff and collect their feedback at the previously scheduled building-level staff meetings on Dec. 11. The District Superintendent joined each of the school Principals at their respective staff meetings to present the framework.
  - The Calendar Committee has recommended approval of the 2019-20 School Calendar which includes a Teacher Institute Day dedicated to eLearning practice/training
