

PEQUEA VALLEY SCHOOL BOARD
Reorganization Meeting
December 1, 2020

The annual Reorganization Meeting of the Pequea Valley School Board was called to order at 7:00 p.m. by President Ferris via Zoom. Members present were Christian Brackbill, Mike Hartmann, Fred Hertzler, Jane Horst, Tim Malloy, Steve Riehl, Michael Sage, and Steve Temple. Appointment of Temporary Chairperson: Fred Hertzler

The report of the Nominating Committee was presented by Mike Sage, who recommended Bryant Ferris for President and Christian Brackbill for Vice President for 2021. Mr. Sage asked for nominations from the floor for the positions of President and Vice President. Hearing none, a motion was made by Mr. Riehl and a second by Mr. Sage, to conclude the nominations.
