BOND 2022: MOVING QUICKLY TO ACCOMMODATE DISTRICT GROWTH

Bond 2022 has been moving full steam ahead since voters approved the initiative in May of 2022. The Board of Trustees has had multiple presentations by Claycomb Associates Architects to prioritize projects based on the needs of our students and available funding.

Some of the behind the scenes work includes:

- Determining current financial capacity once the 2022 taxing valuations were released in late July.
- Preliminary estimates for pricing various projects based on current economic factors and material availability.
- Conceptual drawings along with discussion and changes as needed, for various projects in each proposition.
- Soliciting qualifications and approving a construction manager at risk. This process allows the district a cost effective and time conscious process compared to the traditional design, bid, build process.
- Soliciting and selling bonds.
- Approving architects to proceed with construction drawings for phase I projects.

FINANCIAL GOOD NEWS

London ISD received great financial news for taxpayers and our pirate families at the August meeting of the Board of Trustees.

District financial representatives reported the bond rating agencies were very impressed with the financial policies of LISD noting our growth and commitment to reserves after meeting with Superintendent Dr. Judi Whitis. They proceeded to affirm the Aa3 rating.

Not only did the bond rating agencies rate London favorably, seven bids were also received to buy London ISD bonds. This bid leverage combined with the increased tax value enabled London to sell \$41.290 Million in bonds. The district also received a 3.8772 interest rate which was very competitive among the seven bids.

PROPOSITION A UPDATE

Based on preliminary construction estimates and current available funding the following Proposition A projects are moving forward to the design phase:

Phase I: (\$2,600,000)

- Power relocation infrastructure to accommodate expansion and construction.
- Parking and front drive modifications to accommodate additional parking and moving traffic off of FM43.
- Creation of a back loop connector road from the front of the high school to the elementary school and Pirate Road.

Phase 2:

Elementary (\$15,000,000)

- Additional elementary school parking
- Expansion of the elementary to include a new wing with 14 classrooms, bathrooms, and a teacher work room.
- Play gym, playground, and fencing.

Middle School/High School (\$16,400,000)

- New cafeteria with multiple serving lines and ability to seat 458 students.
- Reconfigured entry for middle school and high school with upgraded security.
- An additional high school wing with seven classrooms and three science labs.

PROPOSITION B UPDATE

Based on preliminary construction estimates and current available funding the following Proposition B projects are moving forward to the design phase:

Phase I: (\$7,290,000)

- Athletics parking to be utilized for sports event parking and overflow high school parking. Parking is planned to include approximately 300 spaces. The connector road in Proposition A will be attached to parking to ease traffic congestion before and after events.
- Entrance to sports complex to include fencing, ticketing booth, concession area, restrooms, and team changing rooms.
- Football field improvements to include drainage infrastructure and turf field for use with football, soccer and band activities, competitive 8-lane track, and the addition of field event areas.
