GRAND FORKS SCHOOL BOARD GRAND FORKS PUBLIC SCHOOL DISTRICT #1 REGULAR MEETING MINUTES October 9, 2023

The School Board of Grand Forks Public School District No. 1 held a regular meeting on Monday, October 9, 2023, at the Mark Sanford Education Center with President Amber Flynn and Eric Lunn presiding.

Board Members Present: Josh Anderson, Dave Berger via phone, Amber Flynn, in person and via phone, Monte Gaukler, Joel Larson, Eric Lunn, Jeff Manley, Bill Palmiscno, and Cynthia Shabb. **Absent**: None.

Student Board Members Present: None. Absent: Ryaan Alshami and Maggie Barker.

<u>Others Present</u>: Dr. Terry Brenner, Superintendent of Schools; Brandon Baumbach, Business Manager; Catherine Gillach, Associate Superintendent of Secondary Education; Matt Bakke, Assistant Superintendent of Elementary Education; Melissa Buchhop, President, Grand Forks Education Association; Michelle Shepperd, President, GFAFB School Board; and Cindy Johnson, Executive Secretary.

<u>Call to Order and Pledge of Allegiance</u>. Flynn called the meeting to order at 5:00 p.m. and the Pledge of Allegiance was recited.

Reading of School Board Meeting Norms. Larson read aloud the school board meeting norms.

<u>Approval of Agenda</u>. It was moved by Palmiscno and seconded by Gaukler to approve the agenda as written. Motion carried unanimously.

Celebrating Success. Dr. Kris Arason, principal, Dani Rowekamp, health careers teacher, and former student Morgan Knudsvig, Dustin Norby, marketing teacher, and former student Clarkson Sande, Kevin Nelson, automotive teacher, and former students Aaron Sullivan and Max Polum, and Paul Zettler, information technology teacher, and current students Dimitri Kolodka and Lauryn Brynjulson, gave a presentation on the Career and Technical Education programs at Red River High School.

Approval of Minutes. It was moved by Lunn and seconded by Shabb to approve the minutes of September 25, 2023, as written. Motion carried unanimously.

<u>Public Comments</u>. Courtney Davis and children spoke about Indigenous Peoples' Day. Victoria Swift spoke about the bussing.

Board Education: Fall Achievement Data 2023. Amy Bartsch, chief academic officer, and Jessica Sporbert

and Amy Rohlk, MTSS coordinators, gave a comprehensive review of current student achievement data. All data in the presentation were generated from the ND Insights Dashboard, ACT, and the STAR Renaissance testing platform.

Berger left the meeting at 6:26 p.m. and re-joined the meeting at 6:30 p.m.

Fall Enrollment Report. Bakke reported on this year's student enrollment for grades K-12. Comparatively, from spring 2023 to fall 2023, enrollment increased by 96 students, and from fall 2022 to fall 2023, enrollment decreased by 7 students. The fall 2023 enrollment was 64 students less than the demographer's projection.

NDSBA Resolutions. The Government Affairs Committee Resolution Report including a list of resolutions that are four years old and recommended for re-adoption as written, as amended, and to be dropped was provided.

President Flynn left the meeting at 6:42 p.m. Board member Lunn presided over the remainder of the meeting.

Finance Committee Report and Recommendation.

Baumbach reported on the September 25, 2023, Finance Committee meeting. Discussion topics at the meeting included a presentation on new market tax credits and their application to the Career Impact Academy, consideration of an information technology

manager position, and the budget and certificate of tax levy for fiscal year 2023-2024.

Flynn re-joined the meeting via phone at 6:46 p.m.

Consideration of Fiscal Year 2023-2024 Final Budget and Tax Levy - Certificate of Tax Levy. Baumbach gave a detailed presentation on the final budget and tax levy for fiscal year 2023-2024. Included in the presentation were a review of the Guiding Change Document, budget timeline, highlights of key assumptions, a review of actual revenues and expenditures for 2022-2023, budgeted revenues and expenditures for 2023-2024, future considerations, and next steps. The administrative recommendation was to approve the budget with a property tax levy of 70 mills for the general fund, 12 mills for miscellaneous, 4 mills for tuition, 3 mills for a special reserve fund, 20 mills for the building fund, 2 mills for special assessments, and 20.68 mills for sinking and interest related to the public referendum passed on May 16, 2023, for a total levy of 131.68 mills. The Finance Committee recommended the same with direction to further reduce expenditures by 1%.

It was moved by Palmiscno and seconded by Anderson to approve the fiscal year 2023-2024 final budget and tax levy as recommended by the administration and finance committee and to file the certificate of levy with the county auditor as required by state law. Motion carried unanimously.

<u>Consent Agenda</u>. It was moved by Shabb and seconded by Manley to approve the consent agenda as follows:

 Teacher appointments of Harris Sandhu, special education teacher effective October 6, 2023, salary \$47,589; Lanie Sandhu, special education teacher effective October 6, 2023, salary \$50,947; and Andrea Goertzen, speech-language pathologist effective October 9, 2023, salary \$44,605. Motion carried unanimously.

Consideration of Snow Removal Services Bids.

Baumbach reported four written responses were received from Fert-L-Lawn, The Grass Guys, Matheson Sweeping, and R&R Snow Removal. The incumbent, RJ Zavoral did not respond. After reviewing the proposals, R&R Snow Removal was recommended to be selected as the lowest responsible bidder based on a comparison of the type of equipment and rates quoted. The rates quoted were:

Loader Tractor - \$100 per hour. Skid-Steer - \$85 per hour. Wheel Loader - \$100 per hour. Hauling (dump truck) - \$95 per hour. Wheel Loader with snow blower - \$75 per hour.

It was moved by Shabb and seconded by Palmiscno to approve R&R Snow Removal as the snow removal vendor for the 2023-2024 school year. Motion carried unanimously.

School Board Self-Assessment Committee Report and Recommendation. Larson reported on the October 9, 2023, meeting of the School Board Self-Assessment Committee and its recommendation for this year's evaluation instrument. Dr. Brenner reported the former instrument was based on the school board meeting norms whereas the recommended instrument went deeper looking at assessments as the Be Legendary training suggested.

It was moved by Shabb and seconded by Manley to approve the new evaluation instrument for this year's school board self-assessment. Motion carried unanimously.

Announcements. Dr. Brenner reminded board members of the open house tomorrow at Nathan F. Twining Elementary and Middle School at which the prospective new school will be announced.

Gaukler commented on the new sign at Red River High School.

Board Requests for Future Consideration. None.

School Board Norms – How did we do? Larson reported the board was awesome in following its meeting norms and the presentation by the Red River High School team was fantastic.

<u>Adjournment</u>. There being no further business, the meeting adjourned at 7:21 p.m.

A little more than a year ago, UND's Dr. Laura Link, Dr. Joel Schleicher, and Dr. Jared Schlenker commenced conversations with school district leadership around establishing a partnership with a graduate degree program tailor-made for Grand Forks Public School District teachers who were interested in seeking an advanced degree. The purpose of creating such an opportunity was to begin "building a bench" for future district leadership opportunities within a total of thirteen varying certifications.


Following several planning sessions which included sending out a district notification for anyone interested in learning more about the opportunity through hybrid face-to-face and online orientation sessions, a total of sixteen teachers went through the registration process at UND and are now fully enrolled in the Master of Science Teaching & Leadership program that kicked off in August 2023.

PROBLEM OF PRACTICE MEETINGS: To personalize learning and ensure scholarly alignment to GFPS' strategic plan, Dr. Joel Schleicher (partnership liaison) will facilitate twice per semester in-person meetings focused on a GFPS-specific problem of practice. These meetings will address and support cohort members' ongoing Scholarly Project development and readiness for progress reports shared during Grand Gatherings.

GRAND GATHERINGS: These in-person meetings take place 5 times throughout the program. Grand Gatherings are designed so that cohort members gain further insight into UND and GFPS leadership, services, key initiatives, and more. Guest speakers from both UND and GFPS are scheduled, and cohort members are expected to engage in Q & A with guest speakers by drawing from course learning and program experiences. Additionally, cohort members will report out on Problem of Practice progress and facilitate an informed Q & A with the audience.

MIDPOINT SHOWCASE: Taking place during Grand Gathering #4, the Mid-Point Showcase includes cohort members' presentations to GFPS' teachers who are not involved in the current cohort. Keynote Biographies

Dr. Kathy Gershman, UND Emeritus Professor

Kathy Gershman is professor emerita of Educational Foundations and Research in UND's College of Education & Human Development. She retired in 2015 after 38 years of service to the University. Over the course of her career, Gershman served as department chair, as well as director of graduate studies for the College. Before joining UND's faculty in 1984, Gershman was a secondary teacher in Boston, MA, having received her B.A. in anthropology from the University of Massachusetts and her Ed.M. and Ed.D. degrees in teaching, curriculum and learning environments from Harvard University.

The author of two books in the areas of pedagogy and education philosophy, Gershman led a highly decorated academic career, receiving the Burlington Northern Foundation Individual Faculty Achievement Award for Excellence in Teaching, Research, Creativity and Service in 1990. She was chosen as one of the "Faculty Stars" by UND Presidential Scholars in 2006, and received the ND Spirit Faculty Achievement Award in 2012. During her tenure, her department received the UND Foundation McDermott Award for Excellence in Teaching in 1991 and 1995, and the Thomas J. Clifford Award for Departmental Excellence in Teaching in 2012.

Dr. Eric Link, UND Provost & Vice President of Academic Affairs

Eric Carl Link joined the University of North Dakota as provost and vice president for academic affairs in July 2021. Prior to coming to the University of North Dakota, Link served on the leadership teams of several universities. He served as provost and senior vice president for academic and student affairs at the University of Houston Downtown, and before that, Link was dean of the College of Arts and Sciences at Purdue University Fort Wayne. He also served as associate dean of the College of Arts and Sciences and chair of the Department of English at the University of Memphis, in addition to a number of other administrative positions.

Link earned his Ph.D. in American literature from Purdue University. He has published ten books, included three authored books, one authored textbook, and six edited collections. He has also published over fifty scholarly essays in a variety of journals and essay collections on topics spanning the field of American literature.

Link has twice served as a Fulbright Senior Scholar, most recently at the University of Fribourg in Switzerland (2012), and before that in Lutsk, Ukraine, where he taught American literature and consulted on program and curriculum development at Lesya Ukrainka Volyn National University (2008). He has also lectured and presented on a variety of research topics at universities in China, Iceland, and England.

SUBJECT: Student Transportation Update

DATE: October 23, 2023

Student transportation services are newly provided by Valley Bus Company this year. Nearing two months into the school year, Administration is providing an update on service provision.

This memo acknowledges the initial challenges faced at the start of this school year. Both Valley Bus Company and the school district are getting used to the partnership and understanding the challenges and opportunities. Unfortunately, this has left, at times, the level of service lower than what is expected by students, parents, our district, and Valley Bus Company.

The bus driver shortage continues in our district, across the region, and the country. With internal training ability, Valley has made progress in hiring new drivers. Furthermore, a relationship with Cities Area Transit has helped provide 2-3 more drivers. Finally, the school district has offered to pay for CDL training on behalf of any school district employee willing to drive as well as provide flexibility in their schedule to accommodate the bus schedule. Although this situation has improved, they continue to hire to add more depth to their list of available drivers.

The length of rides has been longer than what is desired. Some instances are more acute, which is especially important to track and improve to ensure equity for all student riders. As more drivers become available, the option to add routes or increase service presents itself. It will come at a cost, so Administration will consider the opportunity with equity and level of service as a top priority.

Administration continues to explore more innovative approaches. Dr. Brenner has reached out to surrounding schools to identify available drivers (even on weekends for athletic events). Also, to continually improve on-time arrivals and departures the school district is starting work on bell schedule scenarios that could allow more time for drivers to complete their routes.

Valley has been responsive to the school district and has worked to improve its ability to field all calls in a timelier manner. The school district itself is also improving its ability to receive and respond to calls by formalizing and communicating better communication plans. This includes establishing a central email address that is monitored by multiple people ensuring a quick response.

Alli Hillebrand is the district's transportation coordinator and is expected to be out of the office for the short term. Administration has met and clearly articulated a plan for response by dividing responsibilities across specific staff at Mark Sanford Education Center.



Attached you will find two letters of resignation from Jeff Welsh, a teacher presently on a long-term leave of absence this school year (2023-24), and Maura Ferguson, Social Worker at Head Start. Due to the uniqueness of each request, I will provide some context for each employee along with a recommendation for each one.

Jeff Welsh's one-year leave of absence was approved by the school board in the spring of 2023. Mr. Welsh is residing in two locations, Colorado and Grand Forks. He has expressed an interest to substitute teaching for our school district when in Grand Forks and also to serve as a part-time assisting wrestling coach at Grand Forks Central High School. While on leave, per the Teacher Negotiated Agreement, he is unable to be paid by Grand Forks Public Schools. Article V Section 1 of the Teacher Negotiated Agreement provides that a teacher granted a long-term leave of absence shall not be entitled to receive any salary or fringe benefits during the entire term of the leave of absence. In order to create a clear pathway for Mr. Welsh to work for the District, his resignation is necessary so that he would no longer be an employee of the school district. And because he is on leave and currently not on contract, there would not be any financial penalty/liquidated damages associated with his resignation.

The administrative recommendation is to approve Jeff Welsh's resignation effective October 16, 2023.

Maura Ferguson is currently under contract as per the teacher negotiated agreement as a social worker at Head Start. Her resignation creates a vacancy at Head Start which has generated one unqualified application. After visiting with Head Start Director Tracey Johnson, it became clear to me that Ms. Ferguson's resignation puts student and family support at risk.

Attached please find Policy DKBB and DKBB-BR which the school board adopted, in part, due to contracted teachers resigning during the school year and thus breaking their contract. The policy was instituted to minimize, if not eliminate, the recent surge in requests from teachers to be released from their contracts. The latter has created a burden on the district, most notably on the teaching and learning process, in the present workforce shortage environment.

In Policy DKBB-BR, the Board may grant a release from contract for the following reasons:

- 1. Reasons of personal health where a physician's statement supports the request.
- 2. Serious illness or death in the immediate family that requires the contracted staff member's absence for an extended period of time.

3. The Board may, in its sole discretion, grant release from contract for other reasons.

The administrative recommendation is to approve Ms. Ferguson's resignation with the 5% liquidated damages under Policy DKBB under the condition that a social worker replacement can be found, hired, and successfully onboarded, and until that time, Ms. Ferguson should remain under contract for the 2023-24 school year as an employee at Head Start.






General Fund Revenues

The North Dakota Department of Transportation (NDDOT) will be doing some signal rehabilitation along Gateway Drive (US 2), North Dakota, adjacent to Wilder Elementary School. The anticipated start date is May 2025. In order to complete the work, a permanent right of way (fee acquisition) and a temporary construction easement is needed.

The fee acquisition (Parcel 5-1) is needed for a new signal, foundation, and equipment being installed 5 feet east of the existing signal. The surrounding area after existing signal removal will be filled in with concrete sidewalk. The area for this fee acquisition is the pink block pattern in the attached exhibits. For this fee acquisition, the NDDOT is offering \$1,098.00. This amount is based on an appraisal waiver valuation prepared by the NDDOT. I have attached the Appraisal Waiver Valuation below.

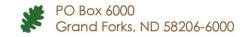
A temporary construction easement is needed for contractor access to the property in the area indicated (red square pattern - Parcel 5-2) on the attached exhibits, to remove the traffic signal pole and foundation which is inside private property. Surrounding area after existing signal removal will be filled in with grass. For this temporary access, they are offering \$300 compensation. The \$300 payment was determined a fair payment to compensate for the time the landowner would expend to review and sign the paperwork and does not represent any specific value.

Administrative recommendation is to approve the attached resolution permitting the fee acquisition for parcel 5-1 and the temporary construction easement for parcel 5-2.



WHEREAS the North Dakota Department of Transportation (NDDOT) completing some signal rehabilitation along Gateway Drive (US Highway 2), Grand Forks, North Dakota with an anticipated start date of May 2025; and

WHEREAS for the NDDOT to complete such work, a permanent right of way easement and a temporary construction easement is needed; and

WHEREAS the permanent fee acquisition is needed for a new signal, foundation, and equipment being installed 5-feet east of the existing signal and the surrounding area after existing signal removal will be filled in with concrete sidewalk and is depicted as Parcel 5-1 in the attached Exhibit.

WHEREAS the NDDOT is offering \$1,098.00 for this fee acquisition and this amount is based on an appraisal waiver valuation prepared by the NDDOT; and

WHEREAS a temporary construction easement is needed for contractor access to the property in the area indicated (red square pattern - Parcel 5-2) on the attached exhibit, to remove the traffic signal pole and foundation which is inside private property and the surrounding area after existing signal removal will be filled in with grass.

WHEREAS for this temporary access the School District is being offered \$300.00 compensation which is a flat payment that has been determined to be a fair payment to compensate for the time the School District is using to go over the paperwork and to sign the easement; and

WHEREAS the NDDOT requires such temporary easement and permanent fee acquisition to be approved by the School Board of Grand Forks Public School District No.1; and

WHEREAS the NDDOT also requires the School Board of the Grand Forks Public School District No. 1 authorize a Grand Forks Public School District No.1 representative to sign on behalf of the School District all necessary documents to accomplish such purposes as specified herein; and

WHEREAS the School Board of the Grand Forks Public School District No.1 hereby desires to grant to the NDDOT a temporary easement for construction access for signal rehabilitation along Gateway Drive (US Highway 2) Grand Forks, North Dakota, and accept compensation for such easement in the amount of \$300.00; and

WHEREAS the School Board of the Grand Forks Public School District No.1 hereby desires to grant to the NDDOT a permanent fee acquisition for the rehabilitation of signals along Gateway Drive (US Highway 2), Grand Forks, North Dakota, and accept compensation for such acquisition in the amount of \$1,098.00.

NOW THEREFORE, BE IT RESOLVED that the School Board of the Grand Forks Public School District No. 1 has approved the temporary easement depicted as Parcel 5-2 on the attached

exhibit and accepts \$300.00 as compensation and approves the permanent fee acquisition depicted as parcel 5-1 on the attached exhibit and accepts \$1,098.00 as compensation for such acquisition for the NDDOT to complete signal rehabilitation along Gateway Drive, (US Highway 2), Grand Forks, North Dakota.

NOW, BE IT FURTHER RESOLVED that Amber Flynn, the President of the School Board of the Grand Forks Public School District No.1 is authorized to sign the necessary documents to accomplish the temporary easement and permanent fee acquisition as specified herein.

NOW, BE IT FURTHER RESOLVED that execution of this Resolution is conclusive evidence of the Board's approval of this action.
