## 2021-22 School Overview

### Principal's Message

The Gateway Community Day School (CDS) program serves the needs of students, grades 7-12, with behavior issues that present a serious barrier to their learning or to the learning of others. Students may enter the program in any of three ways: 1) Referral by County Probation 2) Referral through the SARB (behavior) process and 3) Student expelled (including suspended expulsion). The goal of the Gateway CDS program is to assist students in developing the pro-social traits and skills that will facilitate success in the comprehensive classroom and school setting. The Community Day School staff work very hard to meet the academic needs of each student, while holding the student accountable for demonstrating consistent responsible and respectful behavior. The use of a classroom level-system helps each student to track their individual academic and behavior progress as they acquire the social/behavioral skills and academic habits that will assist them in successfully completing the CDS program. Students who attain the appropriate level and maintain it for the required length of time are considered for transition and may be returned (on-contract) to a comprehensive school site.

## 2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Gateway Community Day School follows the State Instructional Materials Adoption Cycle, which reviews instructional materials in each curricular area within a seven-year cycle. Site and District Department Chairs, along with site administrators and the Faculty Advisory Board, review textbook needs and make recommendations for adoptions. Recommendations are forwarded to the Board of Trustees for approval.

Gateway Community Day School students have access to the library at Mountain Lakes High School. The library is stocked with numerous educational and recreational books that are available for students to check out.

Computer resources within the library are connected to the Internet so that students are able to access resources and information online. In the classroom all students have iPads and these devices are connected to the Internet. Using software programs helps develop critical thinking skills, technological skills, and mathematical proficiency.

Gateway Unified School District (GUSD) held a public hearing in the beginning of the year and determined that each school within GUSD has sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California.

All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and, when appropriate, to take home. All textbooks and instructional materials used within the District are aligned with the California State Content Standards and Frameworks and have been approved by the Board of Education.

## School Facility Conditions and Planned Improvements

The Gateway CDS program is housed at Toyon Learning Center, along with Mountain Lakes High School. This former elementary school site was completely modernized during the 2003-04 school year. Renovations included classrooms, school office, and media center along with a new roof and heating/central air unit. The plumbing, electrical, and technology infrastructure was also updated.

To ensure student safety, supervision is provided on campus at all times. Since the school is so small, the teachers supervise students at all times. All visitors to the campus must sign in and out at the office.

**Cleaning Process:** Gateway Community Day School provides a safe and clean environment for students, staff, and volunteers. The District governing board has adopted cleaning standards for all schools in the District. A summary of these standards is available at the District office for review. A joint effort between students and staff helps keep the campus clean and litter free.

**Maintenance and Repair:** The school site custodial staff administers a scheduled maintenance program. The principal works daily with the custodial staff of three to develop cleaning schedules that ensure a clean and safe school.

Additionally, an operations and maintenance program is administered by GUSD to ensure proper care, protection, and improvement for all classrooms and facilities. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and

## Professional Development

Annually, the District schedules three staff development days where teachers are offered a variety of professional growth opportunities based on current needs assessments. Topics have included Social Emotional Learning, Trauma Informed Practices, Evaluation of Math and Science Curriculum, Intervention for English Language Arts and Math, Technology, Writing Development, Tutorial Assistance, Analysis of SBAC Results, School Climate and Student Discipline, Essential Standards Review, Curriculum Alignment, Special Education, and Strategic Planning. District literacy coaches and the district math coach provide professional development and mentoring to beginning and experienced teachers. Individual teachers are selected to attend Professional Development outside the district depending on necessity and opportunity.

Teachers in the Gateway Unified School District may utilize the Peer Assistance and Review (PAR) program, which uses exemplary teachers to assist permanent and beginning teachers in the areas of subject matter knowledge and teaching strategies. Faculty members may also participate in the New Teacher Induction Program (TTIP), in which a facilitator works with beginning and veteran teachers in improving their skills and addressing the California Standards for the Teaching Profession.
