Priority District Updates

School Opened Smoothly

District Code of Conduct Review - Underway Through October 11, 2023

To repeat an update from the last BOE meeting, we are in the process of reviewing the *District Code of Conduct* for annual revision. Posted on the Website, on the page dedicated to the *District Code of Conduct*, is a memorandum outlining the review process. We advise all interested parties to read the memorandum carefully as a guide for reviewing the current *District Code of Conduct* and to be aware of next vear's review plans. Please note in the memorandum the links to the school-specific *Discipline Code for Students*, which are the guiding frameworks for student behavior in the 2023-24 school year.

Parallel to this annual district-wide process, each building has opened the vear by introducing its specific Discipline Code for Students. For instance, at various times last week, Hillside building leadership hosted Welcome Back assemblies for each grade level to teach students about the Hillside Discipline Code and the importance of following rules. An article about the assemblies will be shared in Thursdav's Hastings Happenings (9/14). Administrators and teachers will reinforce and refresh the expectations throughout the year, especially by raising up examples of dignified and respectful behavior.

September 11, 2021 Observation

Across the district, we observed a moment of silence on Mondav morning in recognition of 9.11. With age-appropriate statements, each school paid its respects to the victims of 9.11 and honored the "heroes of that tragic and heartbreaking day, who emerged from every corner of society."

Drs. Mamie and Kenneth Clark Commemoration Project

We are pleased to be part of a path-breaking "town-gown" (Village-District) partnership to honor an essential piece of Hastings history, which has had a nation-wide impact. The BOE will hear tonight from Hastings residents (Eddie Crawford, Caitlin Chang and Jennifer Ito), who have been instrumental in designing and launching a Village and District program this fall to commemorate the life-changing work of Drs. Mamie and Kenneth Clark. The presentation is posted with the BOE Agenda for the meeting. District leadership for the multi-phase project has come from Greg Smith and Dr. Jenice Mateo-Toledo, which will include a series of activities for students this fall. Key events include:

- September-October An exhibit about the Clarks to be displayed in the HHS Lobby, before moving to the Hastings Historical Society through fall 2024;
- October 12-13, 2023 A visit by Minnijean Brown-Trickey, of the Little Rock Nine, who lived with the Clarks in Hastings in the late 1950s, to speak with students;
- October 14 Unveiling Ceremony for the Clarks' Street Sign (signifying the co-naming of a portion of Mount Hope Blvd as "Drs. Mamie and Kenneth Clark Way") at the James Harmon Community Center from 2:00-4:00 p.m.

In addition. Dr. Szvmanski has organized a special educational session for students in grades 5-12 on *Brown v. Board of Education.* which was substantially shaped by the research of Drs. Kenneth and Mamie Clark. On Tuesday. September 26. at 7:15 p.m., the district will host a session via Zoom for families and students in grades 5-12 to learn about the landmark *Brown v. Board of Education* court case. Participants will learn about the role Drs. Kenneth and Mamie Clark played in one of the most important court cases in the 20th century. A Park Ranger from *Brown v. Board of Education National Historical Park* (Topeka, KS) will explain how legal segregation began in America and how Drs. Kenneth and Mamie Clark were able to provide evidence that led to the desegregation of public schools and influenced the Civil Rights Movement.

A. Report from Assistant Superintendent, Curriculum and Instruction

Commemorative Events: Street Renaming & Brown v. BOE

The Hastings Historical Society has been working on a series of commemorative events and plans, which is outlined in an update they shared this week:

In April of 2023, a subcommittee of the Hastings Historical Society was formed. The team has come up with a series of commemorative events and plans, which are outlined below. In December of 2022, three Hastings residents – Caitlin Chang, Eddie Crawford, and Jennifer Ito – came to the Historical Society to say that more could be done to honor the Clarks. The trustees of the Historical Society agreed wholeheartedly, and, in April of 2023, a subcommittee of the Hastings Historical Society was formed. The team has come up with a series of commemorative events and plans, which are outlined below.

Phase 1 will co-name a portion of Mount Hope Blvd. as "Drs. Mamie and Kenneth Clark Way." Hastings Mayor Niki Armacost and the Village Board of Trustees adopted the street sign proposal on February 23rd and will fund this phase of the project.

This summer the Hastings Public Library has put together a series of discussions, lectures and films about the fascinating people who were connected to the couple, many of whom visited the Clarks' home in our village; these included James Baldwin, Dr. Martin Luther King, Jr., and Jackie Robinson. For more info on this library program, click here.

The Historical Society is preparing an exhibit on the Clarks and their accomplishments, which will be on display in the high school lobby in mid-September. The panels will move from the high school, with an expanded set of exhibit materials, to the Observatory Cottage in November, and will be available for public viewing until the fall of 2024.

Other related events for the student body, including a speaker, are planned for this fall. Phase 2 involves the creation and installation of permanent outdoor signage related to the Clarks. We hope to have three panels completed and installed by the end of 2024, which is the 70th anniversary of the Brown vs. Board of Education decision. The cost of this phase is estimated to be approximately \$12,000. Please help us fund this worthy project! We have expenses in connection with the exhibit, as well as those related to bringing in the speaker planned for Phase 1. More significantly, we need donations to fund Phase 2.

Jenice Mateo-Toledo and Greg Smith have been instrumental in their planning process, particularly around the school-based component. Additionally, Melissa Szymanski has been running a parallel process to design a learning session for Hastings families and students in grades 5-12 to teach about Brown v. BOE. This has been designed to coincide with the street renaming. This learning session will focus on Brown v. BOE and the impact that Hastings residents Drs. Kenneth and Mamie Clark had regarding the landmark court case. Melissa traveled to Topeka Kansas over the summer and met with Nick Murray, Brown v. BOE Division Manager for Interpretation, Education, and Visitor Services, to plan the session. Following is the notification blurb that was sent to the community about the upcoming learning session, which will take place via Zoom on September 26th at 7:15pm:

Learn about the role two local residents of Hastings had on one of the most important court cases in the 20th century. A Park Ranger from Brown v. Board of Education National Historical Park in Topeka, KS will explain how legal segregation began in America and how Drs. Kenneth and Mamie Clark were able to provide evidence that led to the desegregation of public school, jumpstarting the modern Civil Rights Movement.

The presentation will last for 40 minutes with 15 minutes for a question and answer session.

Superintendent's Conference Days

We were delighted to welcome our faculty and staff on August 29th with a series of three Superintendent's Conference Days designed by the Professional Learning Community. Highlights from these days include Crisis Prevention and Intervention (CPI) Training for select faculty members, Safety and Emergency Response Training by Altaris, and Darkness to Light Training, the latter of which is focused on recognizing and preventing childhood sexual abuse. Additionally, all members of the faculty must complete the following mandated, self-paced training modules: Digital Security and Protection, DASA/Code of Conduct, Homeless Students, Mental Health Awareness, Sexual Harassment, Student Data Privacy (Education Law 2-d), and Workplace Violence. Also embedded within Superintendent's Conference Day was time for Melissa and Greg Smith to meet with the Social Studies Department to begin planning for the 23-24 curriculum inquiry work. This was a productive and generative session, which will serve to inform the work ahead.
