WHEREAS, the Board of Education has undertaken an extensive and good faith recruitment search for a certified and qualified candidate to be appointed as Superintendent of Schools and was unable to attract qualified candidates that were capable of handling the responsibilities of the position; and,

WHEREAS, the Board of Education desires to continue the appointment of Interim Superintendent John J. Finello, whose vast experience as a Superintendent of Schools and his fluency in the challenging current issues facing the East Islip School District make him well qualified and can provide constancy while the Board continues its search for permanency.

NOW, THEREFORE, BE IT RESOLVED that the Board of Education herewith continues the appointment of John J. Finello, effective July 1, 2012, as Interim Superintendent of Schools for the period ending June 30, 2013; and

BE IT FURTHER RESOLVED that this resolution is subject to the negotiation and execution of an employment agreement between John J. Finello and the Board of Education of the East Islip Union Free School District and the issuance of a waiver by the Commissioner of Education permitting the continued service of John J. Finello as Interim Superintendent of Schools; Seconded by Mrs. Phillips and unanimously approved. Mr. Finello received a standing ovation by those who were present.
