Fareride Bus Transportation Fees

\$300 per student for the entire school year if paid in full by **August 6, 2021**
Maximum of \$600 per family

\$350 per student for the entire school year if paid after August 6
Maximum of \$700 per family

INSTALLMENT PLAN - Parents may choose to pay the fee in two (2) installments. First payment of \$150 **must be received by August 6, 2021**. The second payment of \$150 is due by **November 3, 2021**. If first payment is received after Aug. 6, fee increases as noted above.

Please enroll all children who will ride the bus. Check **N/C** (no charge) if:

- 1) you live **2.5 miles or more** from school **OR**
- 2) you have a free/reduced meals application pending or approved with a waiver on file with the district's Student Nutrition Office **OR**
- 3) if you have three (3) or more students riding the bus. Only two (2) children will be charged a fee per family under the Fareride program maximum family charge of \$600 if paid by August 6, 2021.
