Additional documentary evidence may be required after this Affidavit is submitted and reviewed.

The undersigned understands that this Affidavit is being submitted to the West Irondequoit Central School District for the purpose of establishing the legal residence of the student for school purposes and inducing the District to admit the student to its schools. It is understood that admission of the student by the District does not constitute a determination binding on the District as to the question of residency. The undersigned further understands that the District will rely on the information contained in this Affidavit.

The undersigned further understands that the District reserves the right to request additional information and to investigate the facts and circumstances involving the residence of the student for the purpose of establishing the legal residence of the student for school purposes. In the event that it is determined that the student is not a resident of the District for school purposes, the student will be dismissed from school, and the undersigned hereby agrees to be responsible for payment in full of the tuition charge, plus interest at the statutory judgment rate, and any other damages arising therefrom, including the cost incurred by the District to collect such charges, which costs shall include reasonable legal fees.
