## IV. Finance Committee Report by Jeff Gulan in Chris Pfender's absence

- A. Initial budget projecting for 20-student reduction
  - a. Separate meeting will be held April 18 to look deeper into the budget
  - b. On track to solve some budget issues
  - c. Question raised: With tuition already set, how will the deficit get caught up?
    - i. Possibly combining some classes
    - ii. Reducing some expenses

# V. Holy Name of Jesus Classical School Discussion

- A. Jeff sent informational video prior to the meeting
- B. Biggest risk seems to be finding a headmaster who is committed to stay while the school gets established
  - a. Qualities desired in headmaster: humble, sincere, confident
- C. The right people is more critical than finances
- D. The first year will be spent on public relations, building repairs, etc.
- E. Where do we see enrollment coming from?
  - a. Survey results indicate approx. 40 students interested 3–4 are current Newman students
  - b. Classical is a completely different style of education from Newman
- F. From a financial standpoint
  - a. First year operational costs needed before opening the school
  - b. First phase of upgrades to the building completed in Summer 2023
    - i. Contractor is ready to start work in May
    - ii. Upgrades will be done in steps according to needed space each year
  - c. Raise approx. 2 million dollars over the course of 3 years the Bishop decides what percentage has to be raised up front
  - d. Shortfall will need to be privately funded—not funded by Newman system
  - e. What does the demographic look like 2-3 years from now and is it sustaining?

#### G. Messaging

- a. How do we justify consolidating classrooms at Newman and opening a new school?
- b. Part of the Newman system, but completely different product
- c. Financially autonomous but administrated by Newman President
- d. Define integration w/NCS: share mascot, administration, etc.
- H. Next steps:
  - a. Circle back with ways to address the concerns that were raised
  - b. Fr. Sam Martin will present plan to the Bishop
