SCHOOL BOARD MEETING**

August 16, 2023

The School Board met on August 16, 2023, at 7:00 p.m. in the Rossville School Building Media Center. Members present were Joe Hufford, Nathan Root, Nathan McCullough, Julia Mink, and Jentry Pendleton. Also present were Superintendent Dr. James Hanna, Chad Dennison, Karla Metzler, and Mandi Pennington.

A motion was entered by Nathan Root and seconded by Jennifer Jacoby to approve claims 19340-19399, payroll claims dated August 4, 2023, and the minutes of the August 1, 2023, meeting and Executive session. The motion carried 5-0.

The following *personnel items* were approved:

Jon Vernon resigned as a Teacher and the Varsity Girls Volleyball Head Coach, effective August 3, 2023.  
Shannon Harman was recommended as a consultant for the Department of Student Services for the 2023-2024 school year. Mrs. Harman is a certified school counselor and will coordinate the services provided by Mrs. Dunn and Mrs. Dillingham. (ATTACHMENT I)  
Brent Tonsoni was recommended as a Homebound Instructor as per a student's IEP in English, Math, Social Studies, and Science. Mr. Tonsoni will work with the student for up to six hours per week and be compensated his hourly rate for the hours worked.

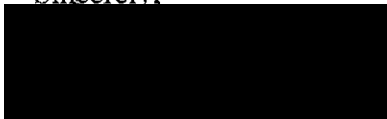
Dear Dr. Hanna:

The contracted licensed school counselor will be responsible for overseeing the Rossville Middle/Senior High School's student service department.

The contracted licensed school counselor will not be responsible for personnel nor will they be substitutes for employees at the contracted corporation.

The fee for this service is \$2,500.00.

The agreement is in effect from July 1, 2023 - June 30, 2024.

The corporation will pay Mrs. Shannon Harman \$1,250.00 biannually (December 2023 and June 2024), or a one-time payment of \$2,500.00 by December 2023.

**A RESOLUTION AUTHORIZING DISPOSAL OF  
VEHICLE TO ROSSVILLE SCHOOLS**

**WHEREAS**, the City of Frankfort, Indiana (hereinafter the "City") owns a 2015 Ford Explorer SUV (hereinafter "SUV"), VIN #1FM5K8AR8FGA88447, and mileage of 130,895 miles, which is no longer in use by the City of Frankfort, Indiana Police Department (hereinafter "Police Department"; and

**WHEREAS**, the SUV has a market value of only Five Thousand Two Hundred Forty-four and 00/100 Dollars (\$5,244.00), according to the Kelley Blue Book publication, and the Police Department anticipates no further use of the SUV;

**WHEREAS**, Rossville Schools is a tax-exempt entity under §501 (c) (3) of the Internal Revenue Code, and

**WHEREAS**, Rossville Consolidated School District has a use for said SUV and Rossville Consolidated School District has agreed to donate a vehicle of similar value to the Police Department for use in Crisis Negotiations;

**WHEREAS**, Rossville Consolidated School District, is willing to accept the donation of the SUV by the City and has agreed to continue utilizing the SUV within its public school district for school-related purposes, all of which serves a public purpose; and

**WHEREAS**, the City has the authority by reason of Indiana Code § 36-1-3-4(b) to donate the SUV to Rossville Consolidated School District and is not restricted from such donation pursuant to Indiana Code § 5-22-22-1(b)(7).

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Public Works and Safety of the City of Frankfort, Indiana that the City of Frankfort, Indiana Police Department, be and is hereby authorized to donate the SUV described above to Rossville Consolidated School District for no consideration; and that Carol J. Bartley, Clerk-Treasurer of the City of Frankfort, Indiana is authorized to sign the motor vehicle certificate of title and any other documentation required in order to transfer title and possession of the SUV to Rossville Consolidated School District.



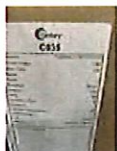
