## APPLICATION FEE

Parents/guardians may enrol a student by completing an Application Form and paying a Fee of \$150 (includes GST). This fee covers administrative costs and is non-refundable. On payment of the Application Fee, names are then placed on our wait list. Completion of the form and payment of the fee does not guarantee admission of a student to a place at the College.

## ENDOWMENT FEE

Confirmation of a student's place in the College follows the completion of an Enrolment Form, the successful completion of an interview and the payment of a non-refundable Endowment Fee. The Endowment Fee is charged as per the table below:

## FAMILY FEE CONCESSIONS

Tuition Fee concessions are offered for multiple children enrolled concurrently as follows:

First child	No concession applies
Second sibling	10%
Third sibling	15%
Fourth sibling	20%
Fifth and subsequent sibling/s	25%

Concessions apply only to Tuition Fees and are assigned to the younger sibling/s.

## PAYMENT METHODS

The default payment option is monthly. **An email requesting parents to indicate their chosen option will be sent out by 15 December 2023 and the response must be received by 8 January 2024.** Any parents who wish to change their payment option after this date will be charged an administration fee of \$50.

**Credit Card:** Available on MyASC (Select the Parent Gateway). A surcharge fee of 0.91% applies to Visa and Mastercard and 0.95% for American Express.

**Direct Debit:** Automatic payments can be made from a nominated bank account or credit card by downloading a Direct Debit Request Form from MyASC under Parent Information. A surcharge fee applies to credit card payments made via this method.

## GST

Most fees and charges are GST free; however, the College reserves the right to charge any GST that may be applicable and payable by the College.

### MUSIC FEES

Music Fees for individual tuition cover of 32 x 30 minute lessons. Lessons of different time duration will be charged on a pro-rata basis.

Music fees will be \$1,632 for the year payable as follows:

February 2024 (Semester 1): \$816

July 2024 (Semester 2): \$816

Instrument Hire (per Semester): \$130

NB: Year 12 students are charged for Semester 1 and 50% for Semester 2 (ie three terms only).

### COLLEGE BUS SERVICE

The College provides a range of morning and afternoon bus services for our students to and from the College. Whilst these bus services are heavily subsidised by the College, a fee is payable for the use of these services. Students can also access the Transperth bus service to and from the Bull Creek train station. Please refer to MyASC – 'Bus service routes and Information' for further details regarding payments, charges and routes.

### PARENTS AND FRIENDS' SOCIETY (P&F)

The Parents and Friends' Society optional annual family membership fee of \$90 will be charged on the February account. The P&F uses these funds to enrich the community at All Saints' College.

### VOLUNTARY BUILDING FUND (VBF)

This is an optional and tax-deductible payment which families are invited to make when paying tuition fees. Tuition fees generally cover just the day-to-day operating costs (eg salaries and resources) of running the College, therefore there are many benefits from all additional sources of financial support for capital projects. Through the generosity of our community, the VBF has funded the installation of a comprehensive network of CCTV cameras across our campus, enabled the fit-out of The Hangar, enclosed our Canteen, and air-conditioned the College Chapel, to name a few.

Receipts will be issued for donations to the VBF to enable a tax deduction to be claimed.

### INSURANCE

Personal accident insurance is provided for all students of the College. Details are available from the Accounts Department.

### RESPONSIBILITY FOR BREAKAGES/DAMAGES

Payment for damage to any College-owned property or another student's property is the responsibility of parents or guardians. The College does not accept responsibility for loss or damage to students' personal effects or College property that is caused by students or parents.

## ABSENCE FROM THE COLLEGE

No reduction of Tuition Fees or the Information Technology Charge will be made because of absence from the College, as costs incurred in operating the College are not lessened by the absence of individual students.

## LATE PAYMENT OF FEES

Parents who are experiencing difficulty in paying fees by the due date are encouraged to phone the Accounts Department to discuss alternative arrangements for payment.

The College reserves the right to apply a late payment fee of \$110 to accounts not paid within 14 days of the due date, unless a prior arrangement has been made.

In accordance with your enrolment agreement with the College, the College reserves the right to charge interest at the College's bank overdraft rate plus 2% on all fees unpaid by the due dates.

No student may commence a new school term unless outstanding fees have been paid in full or a prior arrangement has been made.

The College reserves the right to take legal action for recovery of fees and charges not paid. Any expenses, costs or disbursements incurred by the College in recovering any outstanding fees and charges, including debt collection agency fees and solicitor costs, shall be recoverable by the College.

Where fees remain outstanding, the Principal reserves the right to cancel a student's enrolment unless a prior payment arrangement has been made and adhered to.

Applications to participate in College-organised tours may not be accepted unless all outstanding fees have been paid.

## BURSARIES

Temporary assistance may be available where families experience short-term financial difficulties. If such circumstances arise, you should contact the Director of Business and Administration in the first instance. Such matters are treated in the strictest confidence.

## SECONDARY ASSISTANCE SCHEME

The Secondary Assistance Scheme is available to parents of independent secondary students who hold eligible concession cards. It comprises an Education Program Allowance which is paid to the College, and a Clothing Allowance that can be paid to the College or the parent.

Forms are available from the Accounts Department. Applicants need to provide proof of eligibility and an accounts officer needs to sign the form. This must be applied for in the first term of each year that applicants are eligible.

Applications close 28 March 2024.

## NOTICE OF WITHDRAWAL

The Principal must be given a full terms' notice in writing prior to the withdrawal of a student from the College, or a 25% fee in lieu will apply. If an enrolment is not to continue in 2025, written notice must be given by the final day of Term 3, 2024 or the 25% fee in lieu will apply.
