The **Community Foundation of Hancock County** (CFHC) is a nonprofit organization that works with community partners to build a future for Hancock County, Indiana. CFHC’s principal function remains serving donors and their community. We are a tax-exempt 501(c) (3) organization providing donors with flexible, efficient, and tax-effective ways to ensure that their charitable giving achieves the greatest possible impact.

CFHC receives gifts from individuals, families, organizations, corporations, and other foundations. # How to Apply

## Students!

CFHC offers scholarships to graduating high school students, college students, and non-traditional students who are pursuing a post-secondary education credential.

## Prepare

The CFHC Scholarship Applications may require:

- ✓ Student contact information.
- ✓ Letters of recommendation.
- ✓ FAFSA Report information.
- ✓ The last four digits of your social security number in order to create your Applicant ID number.
- ✓ List of community services and extra-curricular activities.
- ✓ Digital headshot required in June for scholarship recipients only (no selfies).

## Apply

Easy as 1, 2, 3

Access the online application at [www.CelebrateHancock.org](http://www.CelebrateHancock.org)

- 1 Create an account on the CFHC Scholarship site using a permanent email address and password. Bookmark this link for easy return access.
- 2 Complete the Universal Application. This generates a list of scholarships for which you are eligible based on your answers.
- 3 Finish and submit the specific scholarship applications for which you are eligible.

1. Read and review the list of scholarship descriptions in this Guidebook to determine criteria and eligibility requirements. Each scholarship is listed on pages 6 and 7 under the following categories: college students, public high school, private and parochial high school students, students graduating from specific Hancock County high schools, students who participate in the 4-H program, Trade and Technology Scholarships, and out of county students.
2. Visit the CFHC website at [CelebrateHancock.org/students](http://CelebrateHancock.org/students) and click on the link for the online application. Follow instructions on the screen to create an account. Keep your username and password safe, as you will use it every time you revise or submit any CFHC scholarship application. Create a bookmark in your internet browser for easy access to this site. You will be directed to fill out a "Universal" application with an eligibility quiz embedded in it. When the Universal Application has been submitted, you will be directed to the applications of scholarships for which you are eligible.
3. Complete your first application. **Make sure all the fields are filled out completely and correctly before you move on to applying for more scholarships, since this information will be automatically added to other applications requiring the same information. Any time you change or update information in one application, that information will be updated in the other applications.**
4. Scholarship applications may require letters of recommendation, obtained through the "Recommendations" section on the online application. You will need the email address of your recommenders in order to request those letters of recommendation. Recommendations may NOT be written by family members. Recommenders will be sent an email requesting the letter through the scholarship website. You will not be able to view the letters, but will be able to see if the recommender has submitted his or her letter.
5. All scholarship recipients must submit one high-quality, color head shot (shoulders and up). A professional senior photo is preferred. CFHC reserves the right to request additional photos if the submitted photo is not acceptable. \*Please note, if you are selected as a scholarship recipient, this photo will be used in CFHC publications.

**Each scholarship application becomes valid only when completed in its entirety and the "Submit" button is clicked. Also letters of recommendation must be received by February 9, 2024 at 4:00 p.m. in order for a scholarship application to be valid. You may submit your application even if you have pending recommendation requests; the application status will be SUBMITTED until the requests have been received. The status will be changed from SUBMITTED to COMPLETE once all requests have been received. Late applications and letters of recommendation will not be accepted!**

## **Am I eligible to apply?**

Each scholarship fund is set up differently to meet the wishes of the founding donor; therefore, each scholarship has its own set of requirements to apply and its own selection criteria. A complete list of scholarship funds with detailed information on requirements and criteria is available on pages 8-38 of this scholarship guidebook.

## **I'm not a "straight A" student.**

### **Are there scholarships available for me at CFHC?**

Many CFHC administered scholarships do not include academic performance as a selection criterion, and there are others that only require that you have a minimum seventh semester GPA.

## **I do not plan to pursue a traditional bachelor's degree. Am I eligible to apply?**

Yes, several CFHC scholarships are designated for those who wish to pursue any post-secondary education credential.

## **If I graduate early, am I still eligible for scholarships?**

Applicants must meet or exceed minimum secondary education graduation requirements, regardless of class standing, to be eligible for scholarship funds requiring graduation from a secondary education institution. All scholarships designated for graduating students will be awarded the May after students complete their minimum requirements.

## **If I'm currently a college student and attended college immediately after high school, can I continue to apply for CFHC scholarships?**

Yes, you will fill out the Universal Application December 1-February 9 and be directed to scholarships available to current college students.

## **Can I receive more than one scholarship?**

It is possible for students to be selected for more than one scholarship.

## **How much does it cost to apply?**

There is no application fee.

## **What are the amounts of scholarship awards and how are they determined?**

Scholarships are grants generated from the income earned from endowed (permanent) funds administered by the Community Foundation of Hancock County on behalf of donors. Because grants are determined based on a percentage of income earned, some fund awards equate to unusual dollar amounts and can vary from \$500 to much more. Specific amounts for most scholarships can be found in the scholarship descriptions on pages 8-38.

## **What kinds of costs can my scholarship cover?**

All CFHC-administered scholarships must be used for billable fees (ie. tuition, required fees, room and board, and in some cases, required course-related expenses such as books, supplies, fees and equipment) unless otherwise outlined in the scholarship description on pages 8-38. We encourage its use for non-taxable purposes including tuition and required fees.

## **Is my scholarship renewable?**

Most CFHC administered scholarships are one-time scholarships unless outlined in the scholarship amount on pages 8-38.

## **When will I be notified?**

Scholarship recipients will receive an e-mail in late April informing them of the total amount they have been awarded. Recipients who are graduating students will be notified of their specific scholarship(s) at the Senior Awards Ceremony at their respective high schools. College students will be notified via mail of their award by the end of May. Some 4-H Scholarships will be presented during the Hancock County Fair in June. In early June, a follow up will be sent from the scholarship system requesting college and final contact information. Information from this form will be used to issue the scholarship award to the appropriate school/college. Applicants will be notified via email if they are not awarded a scholarship.

## **If I receive a scholarship, how is the money disbursed?**

CFHC policy requires scholarship checks to be sent directly to the eligible educational institution\* in which the scholarship recipient enrolls. For most scholarships, this information is provided by the recipient on the recipient information form. Checks will be mailed in July.

*\*Eligible educational institutions are those whose primary function is the presentation of formal instruction and that normally maintains a regular faculty and curriculum and normally has a regularly enrolled body of students in attendance at the place where it carries on its educational activities. It is also accredited by a nationally recognized accreditation agency.*

## **If I plan to take a "gap year" after graduating high school or otherwise delay my post-secondary enrollment for a year or more, will CFHC hold my scholarship for me?**

No. CFHC policy is that scholarship recipients must utilize funds during the academic year immediately following their scholarship award unless otherwise denoted. "Gap years" or interruptions between award of the scholarship and the beginning of postsecondary education in the following academic year will cause the recipient to forfeit the scholarship. Unusual situations may be considered.

## **Who should I contact if I have questions about a scholarship or the application?**

You can always check the status of your application and whether your letter(s) of recommendation have been submitted by logging in to your scholarship portal. If you are a current high school student and still have questions after checking your portal, first contact your school counselor or the scholarship coordinator at your school. # Scholarships

## for Adults & Non-traditional Students

The Community Foundation of Hancock County offers educational support for non-traditional (or adult) students who are seeking post-secondary training or schooling to improve their career prospects. Whether you delayed post-secondary enrollment, work full time, are a single parent, don't have a traditional high school diploma, or are a military veteran, these scholarships are for you. The application is open year-round at [CelebrateHancock.org](http://CelebrateHancock.org) until all funds are used.

### What You Should Know:

- 1) Applicants must qualify as an "independent student" as determined by the Federal Application for Free Student Aid (FAFSA).
- 2) Applicants must have had their normal course of education interrupted for any reason.
- 3) Applicants must plan to pursue a post-secondary education credential at the undergraduate level in an online or traditional setting.
- 4) Recipients will be chosen based on financial need.
- 5) Applicants will have a personal interview with representatives from Leaders in Navigating Knowledge (LINK) and the Community Foundation of Hancock County.

### Adult Re-Education Fund

Established by John and Linda Zimmermann, this scholarship provides support to adults who wish to obtain additional education and/or training in order to increase employment opportunities.

### Cargold Scholarship

This scholarship was established by Dennis and Evelyn Chapman to honor Dennis' parents and their belief in higher education.

### Nancy King "Dare To Dream" Fund

The purpose of this fund is to honor the Greenfield Kiwanis Club, a group whose members were like family to Nancy, through the provision of scholarships to persons who wish to obtain additional education.

### Helen Roath Memorial Fund

Established by Helen's husband, Rollo, the fund is intended to help adult students return to the classroom. Applications are available through the Greenfield Tri Kappa Upsilon Chapter.

After serving in the Korean War as an Aviation Engineer, he returned to Greenfield and became a respected local businessman as manager of the Broadway Lumber Company and the Weil Theatre. Bill was best known as a member of the Greenfield Banking Company Board of Directors for more than 53 years. This scholarship was established to reward good citizenship.

### Richard and Judith E. White Memorial Fund

Richard, a successful business owner of the local community, and Judith, a registered nurse, both supported those who believed in furthering their own career and making a better life for themselves. Their children, Keith White and Stephanie White-Longworth, established a scholarship fund to provide educational support for non-traditional students.

### LINK – Leaders in Navigating Knowledge

Provides support to individuals in Hancock County so that they can successfully plan, prepare, and pay for education through and beyond high school. LINK's mission is "to be a resource for the community to gather and share information about the variety of educational opportunities in and around Hancock County."

# CFHC Scholarship Program

Every aspect of the CFHC Scholarship Program is carefully executed to ensure the donors' charitable wishes are fulfilled, recipients are impartially selected, and timely payments are made.

## Criteria

Each donor establishes their own criteria at the time the fund is created. It is the job of CFHC to ensure that the pre-established criteria is met by each applicant.

## Definition

A scholarship is a grant made to support a student's education. CFHC offers scholarships for graduating high school students, current college students, and non-traditional students.

## Rules

The Pension Protection Act (PPA) requires the CFHC Board of Directors to:

- Approve the scholarship application questions
- Oversee the selection process
- Appoint a majority of scholarship reviewers to any family scholarship

CelebrateHancock.org to access the Online Scholarship application. Complete the Universal Application and any applications to which you are directed.

## FAFSA & Financial Information

Applications that require financial need information will include a financial need section. FAFSA Report information, including Student Aid Index (SAI) and Estimated Pell Grant totals will be needed to complete this information. See Page 40 for Financial Need Worksheet.

## Evaluation

Evaluators are given the scholarship criteria for each scholarship and asked to blindly (without reference to personal information) evaluate each application to determine the most qualified applicant for each specific scholarship based on the selection criteria.



## Selection

Selections are made by one of two committees: the CFHC Scholarship committee or a School Selection committee. These committees recommend recipients to the CFHC Board of Directors for approval.

## AWARDS!

Scholarships are announced at award programs (if not a graduating senior, you will be notified via mail). Recipients are required to submit an online Recipient Information Form.

## Scholarship Payments

Payments are mailed directly to the college bursar's office and applied to the recipient's account. Funds must be used within the academic year for billable expenses (ie. tuition, required fees, room and board), unless otherwise noted.

## Amy L. McKee-Everett Memorial Scholarship

**DESCRIPTION:** The Amy L. McKee-Everett Memorial Scholarship was established to continue the giving and caring spirit that Amy embodied. This scholarship is awarded to a graduating student of Greenfield-Central High School who plans to attend a post-secondary institution in the state of Indiana.

**QUALIFICATIONS:** Applicants must: 1) be graduating students of Greenfield-Central High School; 2) have a seventh semester minimum grade point average of 2.5 on a 4.0 scale; and 3) plan to attend a post-secondary institution in the state of Indiana.

**SELECTION CRITERIA:** Selection will be based primarily on community service and a giving and caring spirit. Financial need may be considered.

**SUPPORTING MATERIALS REQUIRED:** 1) Letter of introduction without using your name, including why you think you are a good candidate for this scholarship; and 2) FAFSA Report information required.

**SCHOLARSHIP AMOUNT:** \$ 500 | 1 scholarship

## Ann Waitt Memorial 4-H Scholarship

**DESCRIPTION:** This scholarship was created by Walter and his children to honor their wife and mother, fondly remembered by many as making the fairgrounds her second home during fair week. Recipients must be enrolled in the Hancock County 4-H program.

**QUALIFICATIONS:** Applicants must: 1) be Hancock County, Indiana 4-H members who will complete their final year of 4-H activity this year; and 2) plan to pursue, at a minimum, an associate's degree. Applicants need not be residents of Hancock County or attend Hancock County high schools.

**SELECTION CRITERIA:** Recipients will be chosen on the basis of 4-H achievement (40%), school activities (20%), community service (20%), and academic achievement (20%). Two recipients will be chosen.

**QUALIFICATIONS:** Applicants must: 1) be graduating students of a Hancock County public high school; 2) have a seventh semester minimum grade point average of 2.0 on a 4.0 scale; and 3) plan to pursue a post-secondary education credential in a trade or technical program.

**SELECTION CRITERIA:** Selection will be based on leadership qualities and academic achievement. Preference may be given to applicants who plan to pursue an associate degree or a certification. One recipient is selected from each of the four Hancock County, Indiana public high schools.

**SUPPORTING MATERIALS REQUIRED:** 1) List of classes taken in the trade or technical area and how they affected your desire to continue your education; and 2) Paragraph describing leadership qualities and why you think you are a good candidate for this scholarship.

**SCHOLARSHIP AMOUNT:** \$ 1,462 per recipient | 4 scholarships

## Wanda Smith Memorial Scholarship

**DESCRIPTION:** Wanda Smith touched the lives of many students as a 3rd grade teacher at J. B. Stephens Elementary for 15 years. This scholarship, established by Wanda's husband, Rick Smith, honors her love for teaching and helping students succeed. This scholarship will benefit Greenfield-Central graduating students who have attended J.B. Stephens Elementary.

**QUALIFICATIONS:** Applicants must: 1) be graduating students of Greenfield-Central High School pursuing a four-year bachelor's degree; and 2) have attended J.B. Stephens Elementary School and must request documentation of said attendance through the application.

**SELECTION CRITERIA:** The primary criteria for selection is financial need.

**SUPPORTING MATERIALS REQUIRED:** 1) Third party request for proof of having attended J.B. Stephens Elementary in Greenfield, Indiana; and 2) FAFSA Report information required.

**SCHOLARSHIP AMOUNT:** \$ 1,000 | 1 scholarship

## We Before Me Scholarship in Honor of Matt English

**DESCRIPTION:** A Greenfield-Central graduate, Matt English excelled as a basketball player and coach. He was best known for his “We Before Me” mantra, which resonated in his life as a coach, teacher, mentor, husband, father, son, colleague and friend. Matt’s loved ones honor his WeB4Me motto through the recognition of a graduating student who exemplifies the life lessons that he taught and exhibited to hundreds of people until his passing in 2018: Always do for others; always be there for someone, never walk away from being a part of something great.

**QUALIFICATIONS:** Applicants must: 1) be graduating students from public high schools based in the state of Indiana; 2) plan to pursue a post-secondary education credential including trade and technical certifications, associate and/or bachelor’s degrees; and 3) while there is no GPA minimum, applicant GPA will be reviewed in conjunction with stated educational attainment goals.

**SELECTION CRITERIA:** 1) Selfless execution of service that left a situation or a place better than it was before said service; 2) Remaining positive in the face of adversity and facing each day with tenacity, regardless of the circumstances; and 3) Leveraging the unfortunate circumstances of others to identify ways to provide positive benefit.

**SUPPORTING MATERIALS REQUIRED:** 1) 500-word essay describing how one’s service demonstrates one or more of the following: a. Selfless execution of goals to better a team, group, or community; b. Placing community before self; c. Leaving a “mark”, meaning making a place better off than it was before you arrived; d. Remaining positive and facing each day with tenacity when faced with personal adversity for the ultimate benefit of others; e. Identifying ways and executing actions that benefit others when they are faced with unfortunate circumstances; and 2) Two letters of recommendation that share how the applicant has met the spirit of “We Before Me” as described by the scholarship’s criteria.

**SCHOLARSHIP AMOUNT:** \$1,000 each | 2 scholarships

## Wilfong Family Scholarship

**DESCRIPTION:** Many members of the Wilfong family and those they married attended Eastern Hancock High School and resided in Hancock County. Founders of the fund, Cheryl, Dona, James, Paul, and Deborah, honor the Wilfong Family heritage through this need-based scholarship for Eastern Hancock High School students who might not otherwise be able to attain a college education.

**QUALIFICATIONS:** Applicants must: 1) be graduating students or past graduates of Eastern Hancock High School; and 2) minimum grade point average of 3.0 on a 4.0 scale at current or most recent educational institution.

**SELECTION CRITERIA:** Selection will be based primarily on financial need.

**SUPPORTING MATERIALS REQUIRED:** 1) Most current unofficial college transcript and GPA if you are a current college student or you have college credit (NOT applicable for dual credit high school students); and 2) FAFSA Report information required.

**SCHOLARSHIP AMOUNT:** \$ 3,250 | 1 scholarship, renewable at \$ 1,625 for 2 years

## William W. Weil Good Citizen Scholarship

**DESCRIPTION:** William W. Weil was born and raised in Greenfield, Indiana. After serving in the Korean War as an Aviation Engineer, he returned to Greenfield and became a respected local businessman as manager of the Broadway Lumber Company and the Weil Theatre. He was best known as a member of the Greenfield Banking Company Board of Directors for over 53 years, but his charitable heart was always with the young. For this reason, the foundation founded in his name established a multi-year scholarship that provides educational support, including books, fees, and other required materials.

**QUALIFICATIONS:** Applicants must: 1) be residents of Hancock County, Indiana; 2) be graduating students or past graduates of a Hancock County public school; 3) plan to pursue an accredited degree or credential; 4) have a minimum 3.0 GPA and agree to maintain this grade minimum during pursuit of post-secondary schooling; 5) show the donation of a minimum of 20 hours of community service in the most recent twelve month period and agree to this commitment during the pursuit of post-secondary schooling. Documentation of hours must be confirmed by a school or charitable organization; and 6) agree to refrain from illegal drugs, underage drinking, and illegal acts.

**SELECTION CRITERIA:** Selection will be based on ability to demonstrate traits of citizenship through community service and good behavior.

**SUPPORTING MATERIALS REQUIRED:** 1) Minimum of one letter of reference affirming contribution of community service hours; and 2) Positive answer to the following statement: “I understand that verification of my behavior related to drugs, alcohol, and illegal acts is based on the honor system. By applying for this scholarship, I am committing to living a life of good citizenship. I will be honest about my behavior in relation to the use of illegal substances, underage drinking, or illegal acts and will confirm this commitment on an annual basis.”

**SCHOLARSHIP AMOUNT:** \$ 4,000 per recipient | Up to 7 scholarships renewable at \$1,000 for up to 4 years

## Wortman-Lowe Enduring Freedom Marine Corps League Detachment Scholarship

**DESCRIPTION:** Established by those who have served their country, this scholarship provides financial support to those who share their passion. It is awarded to graduating seniors and past graduates in pursuit of a post-secondary education credential.

**QUALIFICATIONS:** Applicants must: 1) plan to pursue a credential at a college, university, or other accredited post-secondary institution; 2) have a minimum seventh semester grade point average of 2.5 on 4.0 scale; 3) be a resident of Hancock, Rush, or Shelby counties (Indiana); and 4) have a family member who is serving or has served honorably in the United States Marine Corps.

**SELECTION CRITERIA:** Selection is based on high character and citizenship. Recipient shall be a person who goes above and beyond expectations, leads by example, and demonstrates a love of country.

**SUPPORTING MATERIALS REQUIRED:** 1) Most current unofficial college transcript and GPA if you are a current college student or you have college credit (NOT applicable for dual credit high school students); 2) One-page (250 words) essay describing academic and career plans and how the military service may play a role in those plans; and 3) Indication of relationship to a family member who is serving or who did serve the United States Marine Corps.

**SCHOLARSHIP AMOUNT:** \$ 1,000 | 1 scholarship

## Zach Lett Running for Excellence Scholarship

**DESCRIPTION:** This scholarship was established by Zach’s family to celebrate his athleticism and passion for life. This fund provides support to graduating Greenfield-Central High School students who have shown evidence of strong leadership and participation in extra-curricular activities.

**QUALIFICATIONS:** Applicants must: 1) be graduating students of Greenfield-Central High School; and 2) plan to pursue an associate’s or bachelor’s degree at a college, university or other post-secondary institution.

**SELECTION CRITERIA:** Selection will be based on leadership qualities, extracurricular activities, essays, and good moral character.

**SUPPORTING MATERIALS REQUIRED:** 1) Two letters of recommendation from teachers; 2) 500-word essay answering the question: “If you observed someone being bullied, what would you do?”; and 3) 500-word essay answering the question: “How do you believe you have made a difference in your school?”

**SCHOLARSHIP AMOUNT:** \$ 2,200 | 1 scholarship
