Good afternoon,

I'm sure I'm wasting my time writing this email because I do not believe any of you with the exception of one person on this email will actually take the time to read this and respond. You guys have one agenda and that is your OWN.

As a high risk person and one that is unable to be vaccinated, I appreciate everyone that has gone out and gotten vaccinated and I

appreciate my son and the other students and faculty wearing masks. I do believe they help slow the spread in the school where social distancing can not be observed. I don't want my son to bring home this horrible virus nor do I or anyone in my household have time to be quarantined for 14 days. As a PTO board member I have to go in and out of the school sometimes and I can do that and feel protected with everyone wearing masks. District five has a problem with overcrowding and you have these students packed in class rooms like sardines and now you want to take away the mask. That is wrong in so many ways. They can not practice social distancing because of the lack of space, there are still students being quarantined, and now you want to take away the mask with a little over a month left in school. Don't you people have anything better to do than to call special meetings for issues that can wait until next year. When I made the decision to let my son go back to school I was under the impression that it would be on a hybrid schedule and mask would be required but you took that away. Now you want to take the mask away too. Please consider mine and others concerns and let us finish the school year out with a mask.
