




ASSETS LIABILITIES RATIO





50 acre site package includes full site grading with prepping, relocating and managing utilities such as electrical, water, sewer and storm drains with engineered surface products. Full depth asphalt paving, large paved areas for parking, guard rails, and spill curbs throughout. Extra measures were put in place due to the existing wetlands nearby. 
