5. History and Growth

In 1947, three men established a privately-held, employee-owned construction firm in Greenville, SC with a focus on character and principle. Together, John D. Pellett, Jr., C. Heyward Morgan, and Nelson Tracy, had a vision for what they could build — their team, their clients, and their community.

The firm initially focused solely on public sector work, but the latter half of the 20th Century brought opportunities to expand into institutional work, including significant projects for healthcare institutions, higher education and collegiate campus projects, and religious organizations. From the 1980s on, our team has successfully completed a wide range of work, from \$100,000 tenant upfits to \$60,000,000 multiphase projects. We've done stick-framed apartments, conventional steel and masonry construction, and even cast-in-place multi-level office buildings. 6-7. Litigation

Triangle Construction was involved in one claim and litigation in 2016 involving a multi-family project in which the owner of the apartment complex wrongfully asserted liquidated damages and refused to pay retainage and change order. The withholding of retainage, in turn, resulted in lien claims by the unpaid subcontractors against both Triangle and the owner. All of the subcontractor claims were resolved within a period of 5 months. Arbitration was resolved with the developer with Triangle payment of retainage received.



The Pearce-Horton Football Complex is a four-level, 44,000 SF facility located adjacent to the existing stadium. It includes a locker room and player lounge/study area for the football team. The building also houses coaches' offices, a team meeting room, position meeting rooms, a sports medicine area, equipment room, and other support space. A new press box, club level seating, and private suites with outdoor viewing areas and catering amenities were also part of the project. The exterior design features traditional columns and pediments that complement existing campus architecture with a brick façade and contemporary glass features. The project was completed shortly before the 2014 season.






