Welcome & Introductions:

The meeting is brought to order @ 3:15pm 11/01/2023. Introductions were made O'Brien (WASC Coordinator – via Zoom), Givens (School Director) Brown (Asst. Director) Fowler (Student/Advisory board), Ghozzy (Parent), Bjorgum (Admin) Moore (Teacher) Greenwood (Teacher)

Other parents, and students were expected, hopefully, they will be able to join next time.

Went through the Advisory Council Document 'What is an Advisory Council' – attached. Went over the voting component.

Approval of previous meeting minutes – April 26, 2023 (action)

The group reviewed the document - and found an error on page 3: Looking ahead: Priorities for 2022-2023. change to 2023-2024. Russell Brown makes a motion to approve the minutes. Johnathon Elfstrom seconds the motion.

Enrollment & Budget Update:

- a. Enrollment at this time/date = 288; this date last year = 217; we are 71 students larger this year.
- b. largest growth grade in 8th and 12th
- c. Advisory teachers are full at 25 students; the only way past that is to hire more teachers,
- d. Caseloads for SPED are similar at 30 students.
- e. Enrollment through 3/22/2024 due to state testing (this is shown on our website). Enrollment capped at 300 students. No date has been set for ending S1 enrollment.
- f. Budget connection to Enrollment is important. Dollars are sent to the San Juan District and then given to the Charter.
 - 1. 100% attendance is what our goal is.
 - 2. 1st log period is = just under 95%
 - 3. 2nd log period is = just under 94%
 - 4. Most students earn 100%. Students earn by completing work (approximately 5 hours of work per subject per week), not by physical attendance.
 - 5. A parent asked do you review work completed or time spent? Mr. Givens answered 1st work completion then the time spent if there is an issue with the work completion piece.
 - 6. A parent asked: what about State Testing dates? Mr. Givens answered: Testing is administered at the latest date in the year as possible.
 - 7. A parent asked: what about assessments at the beginning of the semester? Mr. Givens answered yes; they take the IReady at the beginning of each semester to collect data for growth and possible need

for remediation. A parent also asked about IXL testing and whether the middle school students can get access to i-Ready support.

- g. Funds are used for school facilities and teacher salaries (85% of the budget) Each student brings in \$12,800 ADA as of this year.
- h. We are in a healthy spot. We should have a conservative reserve.

WASC & LCAP Update – School Wide Action Plan 2023-24

Mrs. O'Brien shared a document, 'What is WASC' - attached.

CCS Vision: shared, CCS Mission Statement shared, CCS Graduation Outcomes: shared

In 2018, Choices earned a 6-year WASC accreditation term with a required mid-cycle report and visit in 2021. (Visiting Committee observations shared - very complimentary). What's next? Our current Self-Study document must be submitted to WASC at the end of January 2024. This Advisory Council will have a chance to review the Self-Study document; please devote whatever time you have to its review. Please send any questions, concerns, or suggestions to Mrs. O'Brien's email. She does a great job of ensuring everyone has a voice in this document and that our school represents everybody: Students, Staff, Parents, Community Members, etc.

A parent asked if there were questions about the curriculum, etc. How does she get that information to Mrs. O'Brien?

Mr. Givens takes information and talks it over with parents, staff, and the leadership team and ultimately decides.

Parent says: I understand, I can bring information to Mr. Givens or the Teachers directly in writing or verbally in person/over the phone.

WASC and LCAP are connected: improving the culture and climate of our school for our students.

LCAP has a special emphasis on making sure the gaps are filled for our EL learners, Social, Economic, and foster youth learners.

Mr. Givens shared a QR code for both the WASC School Wide Action Plan and the Comprehensive School Safety Plan.

Comprehensive School Safety Plan Review 2023-24

The QR code is attached to this document. Mr. Givens quickly showed where the document is located on our website and wanted Parents to know what we are going to do in case of an emergency.

Mr. Brown is the head of our School Safety Team. If you have any questions or concerns, please contact him.

d. Mr. Givens will share the one-page document with the Advisory Council Team. Mr. Givens asked if Jack and Mrs. Ghozzy would be part of the School Safety Team.

- f. It is hard to mandate classes to be in person when our school is designed to be independent and remote. However, with new technologies, we can possibly make it more engaging.

 - Parent: all the fun stuff for high school only.
 - b. Givens: the intention is to make it available for everyone, but this is just the starting point right now.
 - c. c. Staff Improvements happen with encouragement to attend staff development training and conferences.

Walk-ins & Visitor Comments:

- h. Mrs. Ghozzy asked if we could get the membership for iReady to give the students lessons in the areas where they scored low.
 - i.Mr. Givens stated that we did have that membership, but for the expensive costs and the low number of students participating, the school made the decision to drop the membership,
- ii.Mr. Givens will look at it again with a lower # of members.
- iii.Mr. Elfstrom would like to see it return, at least for Middle Schoolers
- iv.Jack F. (student) commented that the kids don't like it because it is elementary cartoons, etc.
 - h. Jack F: Gaming Club Jack would like to see a gaming unit on a big screen (developing relationships while still having fun doing things that most kids like).
- v.Keep in mind ratings let's talk about games.
- vi. Finding a teacher that is willing/able to lead this gaming group.
 - vii.Is the lunchroom/lunchtime good? Might be too short of a time frame but could be a good starting time.
 - h. Mr. Elfstrom: Staff Meetings/Leadership meetings are good places for teachers/staff to talk out ideas/concerns. Can we have the same thing for Parents like a PTA?
- viii.Mr. Givens, probably worthwhile let's look into it and see what the attendance would look like. ix.Different ideas were also brought up for Student Fundraising for events they would like to have on campus.
 - h. Mrs. O'Brien asked about Student Leadership. Mr. Givens is taking into consideration the different needs of students on days/times that work for them. The first student leadership meeting did not have strong attendance.



Comprehensive School Safety Plan (Draft as of Nov. 1, 2023)


We are in need of your input and review for our CSSP.
