



All documents can be directly uploaded to Cambrian's online registration system.

- Proof of Age:** An original Certified Birth Certificate, Birth Record, Baptism Certificate, or Passport with a parent/guardian photo ID. *(required to be uploaded prior to submission)*
- Proof of Immunizations:** Your child's yellow immunization card or a printout from your physician, clinic, or previous school. All required immunizations must be met prior to school starting. If all required immunizations are not met, your child will not be able to attend school. See below for more Immunization Information. *(required to be uploaded prior to submission)*
- Proof of Tuberculosis Skin Test or Tuberculosis Risk Assessment:** Santa Clara County Public Health Department requires proof of TB Skin Test or TB Risk Assessment Form prior to entering school. See below for more information regarding Tuberculosis.
  - o If your student has taken a Tuberculosis (TB) skin test their Immunization Record or print out will reflect the date and results.
  - o If there is no proof of the test on their record, the required TB Risk Assessment Form must be completed by the United States licensed care provider.
- Proof of Residency:** Cambrian School District requires two (2) forms of address verification for all students. **ONE** (1) document from **List A** and **ONE** (1) documents from **List B**. All documents must include: Name of Parent/Guardian **AND** Current Address of Residence. *If you live outside of the Cambrian School District boundaries and you are requesting Bagby or Steindorf, an approved Interdistrict Request Form from your district of residence must accompany your registration packet. If you have just moved into the Cambrian School District, you must supply a document from List A in order to register. You will have 30 days from registering to provide the other document from List B.*

Falsification of any information or documents required for residency verification or the use of the address of another person without actually residing there may result in the immediate revocation of student enrollment (Cambrian School District Board Policy 5111.1).*

- 1<sup>st</sup> through 8<sup>th</sup> grade Students:** Most recent report card.
- Special Education Students:** A signed copy of the most current IEP or 504 plans must be uploaded to Cambrian's online registration system.
- Kindergarten Students:** Additional required form below:
  - Report of Health Examination for School Entry: California Law requires a health examination upon school entry. A California health examiner must complete this form and it is required for registration. (Health and Safety Code 124085)
- Transitional Kindergarten and Kindergarten Students:** Additional required form below:
  - o An Oral Health Assessment: California requires your child to have a dental check-up by May 31 of their first year in public school. (Educational Code Section 49452.8)
