## Summary

The following spreadsheet shows the revenue and expenditures by month for the General Funds as of October 31, 2023. The total revenues that is forecasted in the September 2023 budget five year forecast, is \$88,661,981. The adopted budget approved by the Board in September was \$87,086,192 plus carryover encumbrances of \$1,499,480 for a total appropriation of \$88,585,672. The five-year forecast for the fall of 2023 will be officially adopted in November, 2023. The September 2023 five-year forecast budget update and annual budget can be viewed at [www.strongnet.org](http://www.strongnet.org), under the Treasurer’s Department.

## REVENUE

The Strongsville City Schools is forecasting **\$88,661,981 (September Forecast)** in revenue within the General Funds in the 2023-2024 fiscal year as shown on figure 2. As of **October 31, 2023** the District has received revenue in the amount of \$40,018,258 for FY 2024. The District is projecting to receive \$48,836,258 in revenue in the remaining months of the fiscal year for a total projected revenue of \$88,854,516. The September 2023 five-year forecast budget update was presented to the Board at the September 25, 2023 Board Meeting and can be viewed at [www.strongnet.org](http://www.strongnet.org), under the Treasurer’s Department. The five-year forecast for the fall of 2023 will be officially adopted in November, 2023.

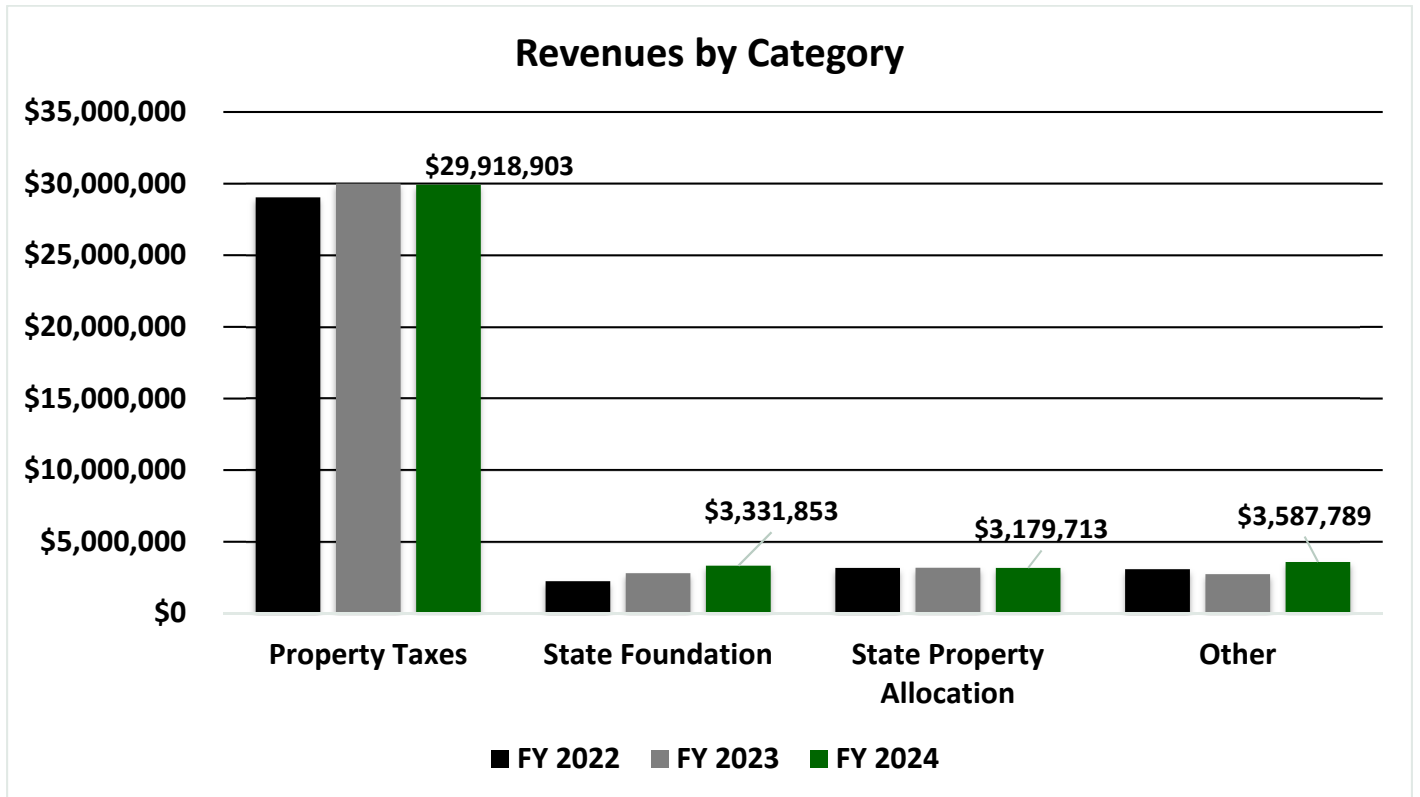
- (a) The District received \$65,576,177 in general real property taxes in FY23 and is forecasting \$65,463,295 in FY24. The current collection rate for collection calendar year 2022 decreased from 96.35% to 94.86%.
- (b) The District will receive state funding in FY24 based on the 2023-2025 biennium State budget, and HB 110, which adopted the Fair Funding Formula. Within the Fair Funding Formula, school district will no longer receive pass through dollars for community schools and vouchers for non-public schools which is represented in the decrease in the table above.
- (c) Projected revenue is based on projected monthly cash balances against the current interest rate. Projected revenue is subject to change based on a change in cash balances and market conditions.
- (d) These revenues have been received as anticipated.
- (e) The District received \$3,113,170 in TIF revenues in FY23 and is projecting \$3,064,511 in FY24.
- (f) Other revenues include cell tower commission, vending commission, sale of property, services provided to other schools, state catastrophic aid, federal medicaid, athletic trainer fees, refunds of prior year expenditures, and other miscellaneous receipts.

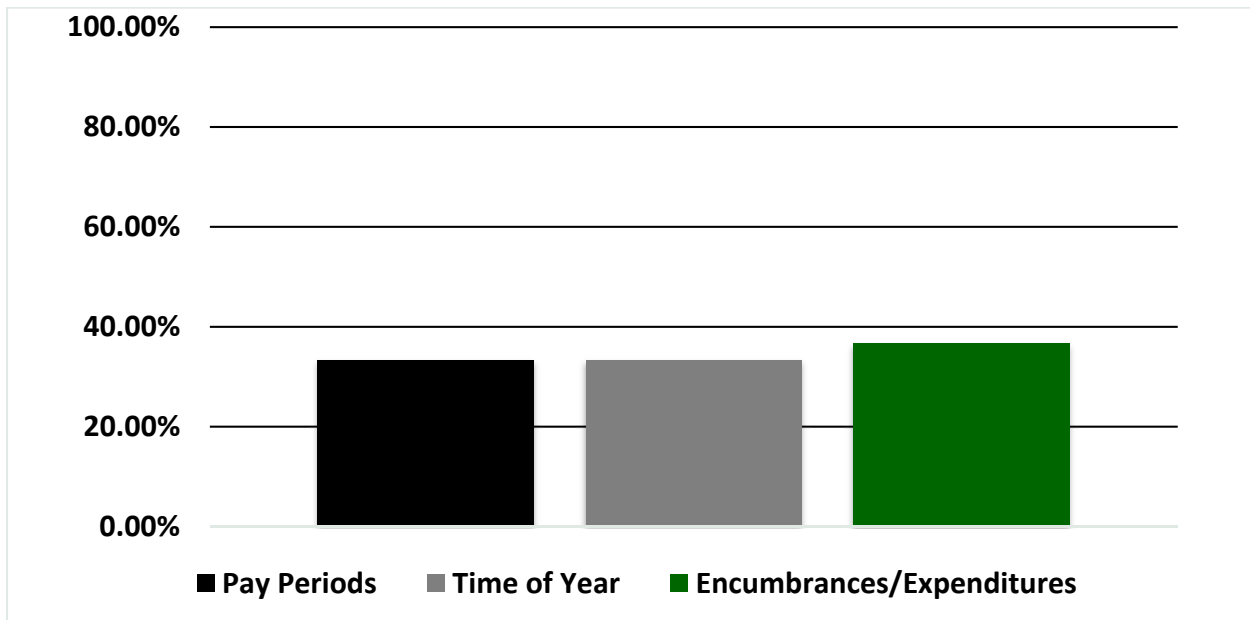

## EXPENDITURES

The fiscal year 2024 adopted General Fund budget for the District is \$87,086,192. This budget, coupled with carryover encumbrances of \$1,499,480, resulted in a \$88,585,672 General Funds appropriation for FY 2024. The following information is a financial update of the status of this appropriation through October 31, 2023.

Through October 31, 2023 the District has expended \$28,212,717 and has outstanding encumbrances of \$4,242,513. This total of \$32,455,230 reflects 36.64% of the District's total appropriation. A statistical spending range for the District is based on two analyses: first, time elapsed is four months or 33.33% of the fiscal year has passed. Secondly, eight of twenty-four (8/24), or 33.33% of the total pay periods have passed. Figure 4 illustrates these points.

Overall, the District's encumbrance/expenditure level through October is over the target based on the above analysis. As an examination of the categories of expenditures is performed, cyclical variances are noted between categories which relate specifically to school opening activities. Figure 5 compares the various expenditure categories to the expected level and to the prior two years. The three years of data will be beneficial for trend analysis performed throughout the year.

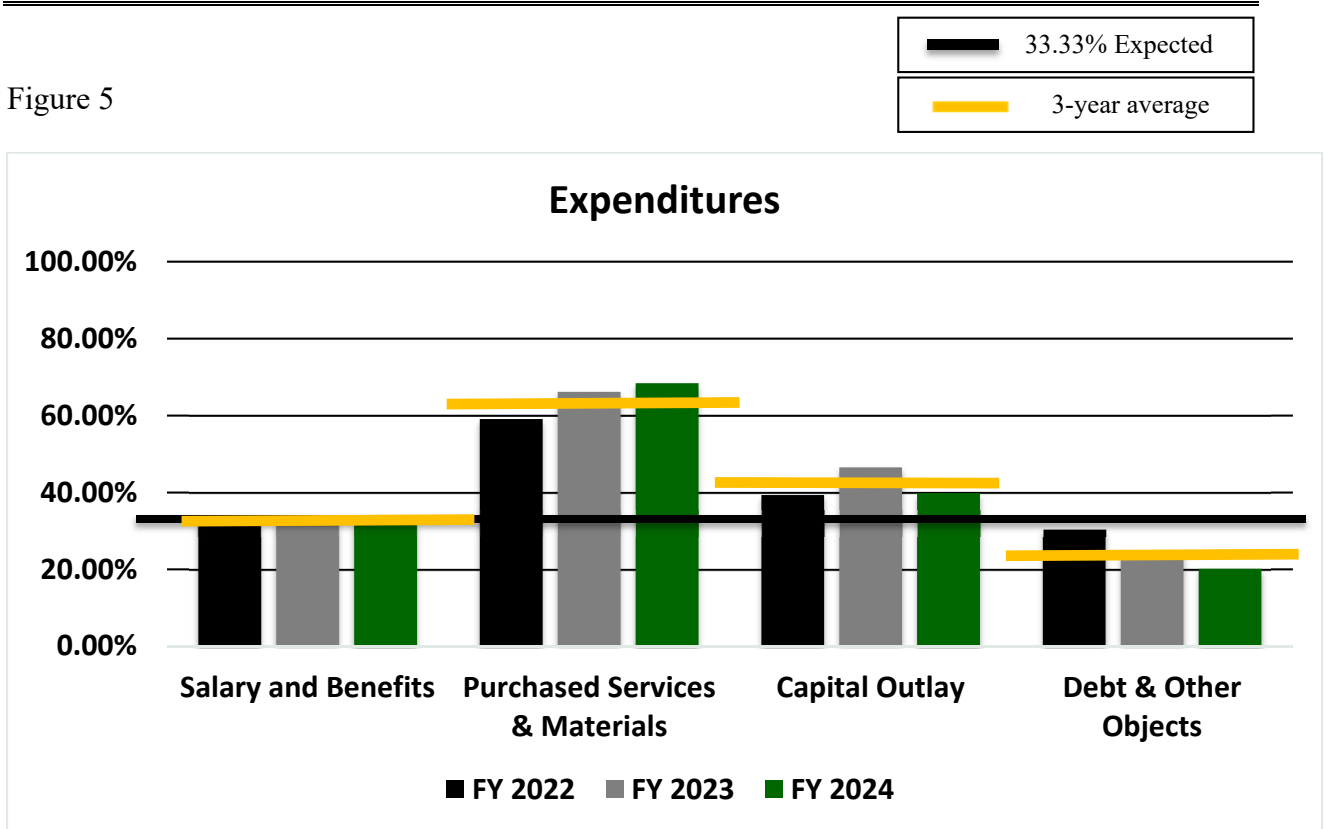
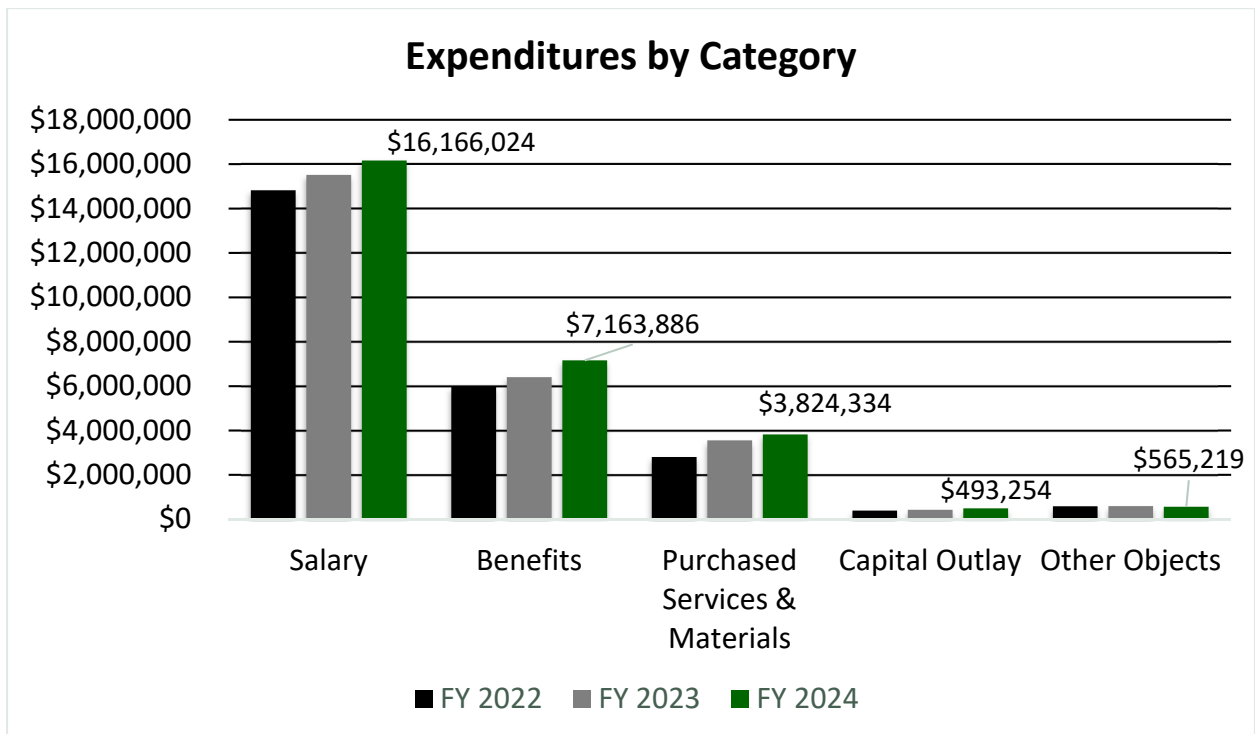

As Figure 6 illustrates, salaries are higher than last year for this time of year which is due to negotiated agreements. We will continue to closely monitor this area for the remainder of the fiscal year. Salaries averaged \$2.1 million in October which is similar to the \$2.1 million in September. Benefits are higher compared to last year which is primarily due to the increase in healthcare and other benefits cost. Healthcare premiums increased 15.00% in fiscal year 2024 from fiscal year 2023.

The current year Purchased Services and Materials categories indicate an 68.41% encumbrance/expenditure level for October. This encumbrance/expenditure rate is higher compared to the 66.18% from this point in time last year. These expenditures vary from year to year base on the timing of when goods are needed and the invoices are paid and received. In addition, many of the annual contracts are encumbered at the beginning of the fiscal year and then spent down during the year. This is consistent with prior years and the cyclical nature of school operations.

The capital outlay encumbrance/expenditure level, whose budget comprises only 1.55% of the total General Fund budget indicates an 39.82% encumbrance/expenditure level for October. This encumbrance/expenditure rate is mainly attributable to school opening cost (technology updates, hardware, etc.). It should be noted that the vast majority of on-going construction and permanent improvements projects are accounted for in other funds and therefore not reflected in the encumbrances/expenditures above.

Finally, the debt service and other objects category of encumbrance/expenditures, which mainly reflects the payment of principal and interest for the energy conservation and facility improvements debt, treasurer and auditor fees, and the transfer of monies to other District funds (as required by State regulations), is as expected as of October 31, 2023. Debt payments occur in November and May while the transfer of monies to other funds will occur in June.

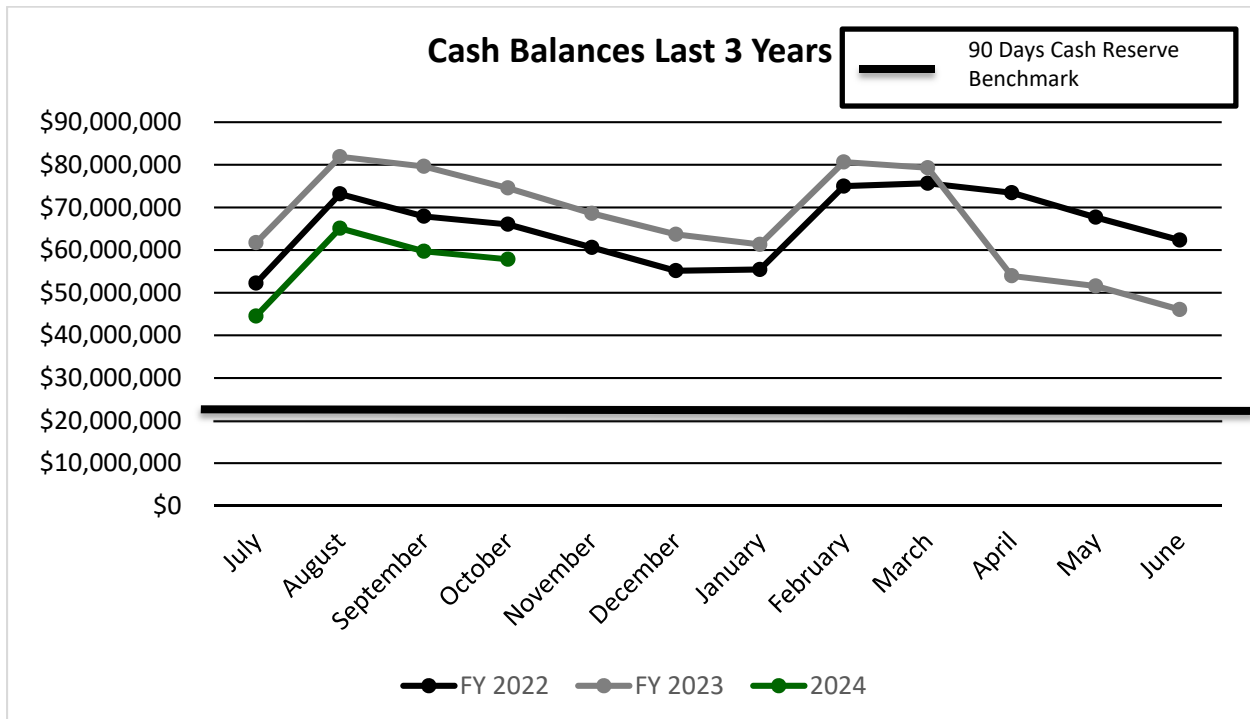
## CASH BALANCES

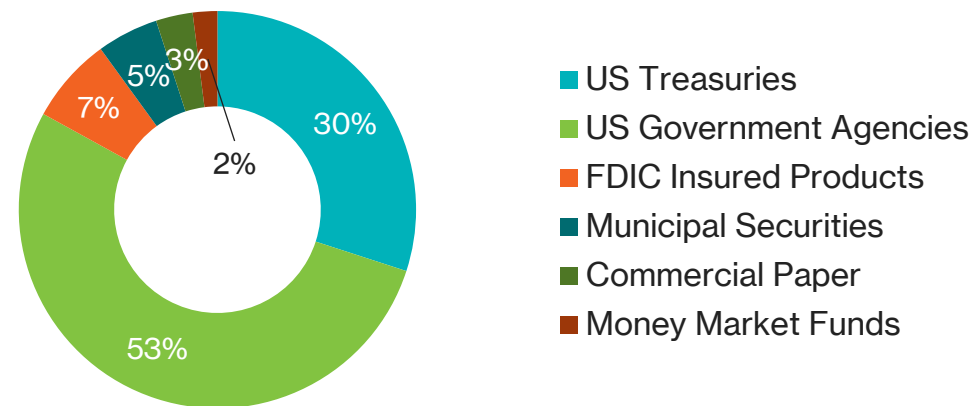

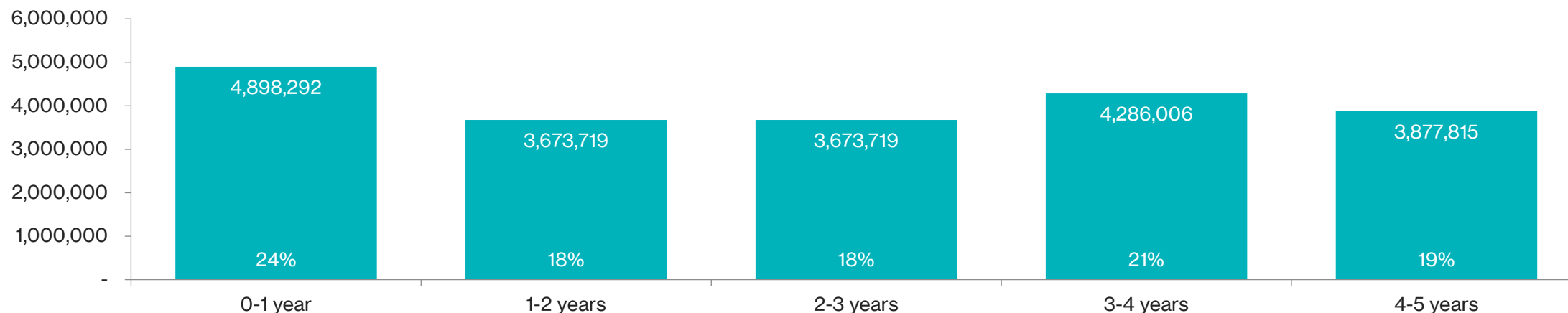

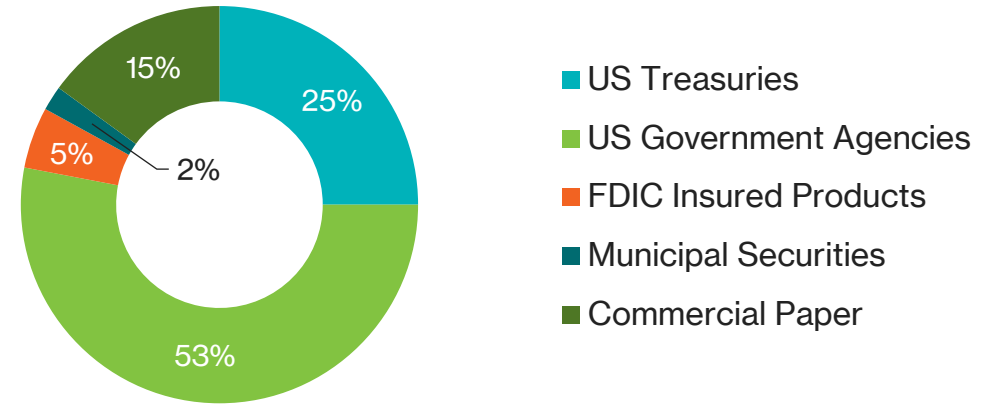

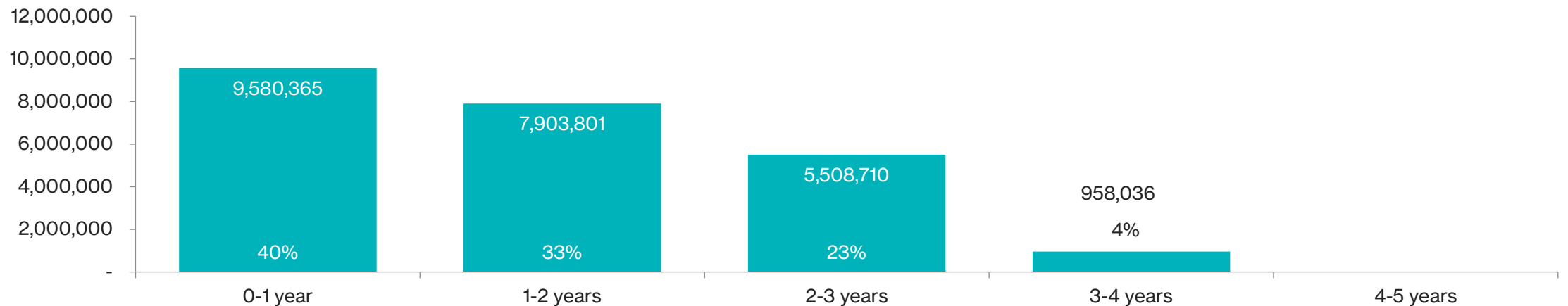
