## **Credential Information**

**Education Specialist Bridge Authorization Program via SDCOE Teacher Effectiveness and Preparation Program** 

The bridge authorization is an option for special education educators whose Education Specialist credential was issued prior to January 2023. This six-week, **fully online** program is designed to meet the California Commission on Teacher Credentialing's updated requirements associated with the new credentials titled Early Childhood Special Education,

Mild to Moderate Support Needs, and Extensive Support Needs. Through the bridge program, special education educators will be authorized to serve a wider range of students and disabilities not authorized in the previous credential.

Registration for the fall 2023 session will begin soon. Educators can join the <u>bridge</u> <u>authorization interest list</u>.
