Corbett Elsen shared Agenda items.

2.0 Discussion/Action Items

2.1) Review of [Parcel Tax COC Bylaws](#) & [Ballot Measure \(M\)](#)

Purpose: Audit function; not decision-making

C. Elsen reviewed Parcel Tax COC Bylaws and Ballot Measure purpose and duties.

2.2) TUHSD Budget Overview - Discuss 2022-23 2nd interim budget report presentation

C. Elsen presented the 2nd Interim Budget Report 2022-2023 presentation that highlighted budget actuals. He explained changes in operating deficit December 2022 at \$1.2 Million and Operating Surplus for March 2023 at \$1.1Million. Noting current reserve at 19.1% not accounting for any potential increase in staff compensation. Board Policy states reserve to be at 17% . Reporting on pending Tentative Agreement with CSEA and moving forward with further discussion on TFT Negotiations, Management and Confidential Classified members raises.

PTCOC members asked clarifying questions in regards to the 17% reserve and asked in regards to the Position Control graph.

C. Elsen clarified that the 17% reserve policy derives from MCOE and Basic Aid district status. State policy for LCFF districts reserve percentage is at 3%.

C. Elsen also clarified that the Position Control graph is shared during the October annual report.

PTCOC members asked clarifying questions in regards to the Boards decision on music cuts. C. Elsen expressed not being able to speak for the Board. However, acknowledged that the decision was not to cut the program but the volume of the program reduce the number of sections of the program given reduced student interest at two of three comprehensive sites.
