**PLEASE TAKE NOTICE**, that in accordance with the provision of Chapter 231, Laws of 1975, the Open Public Meetings Act,” notice is hereby given that the North Arlington Board of Education scheduled a Special Executive Session Board Meeting on **May 2, 2016** at 6:00 p.m. for the purpose of a grievance hearing and student privacy issues. In accordance with the Open Public Meeting Act, the discussion of this matter, which requires confidentiality, shall occur in closed executive session, following which action may be taken at the Special Public Meeting to begin immediately following the Special Executive Session Board Meeting. The meeting will take place at the Board Office, 222 Ridge Road, No. Arlington, NJ. The meeting will open to the public at 6:00 p.m. solely for the purpose of immediately moving into closed executive session as required by the Open Public Meetings Act. Action will be taken.

**PLEASE TAKE NOTICE**, that in accordance with the provision of Chapter 213, Laws of 1975, the “Open Public Meetings Act,” notice is hereby given that the North Arlington Board of Education has scheduled a Special Public Board Meeting on **May 2, 2016** to begin at 7:30 p.m. ***after*** the Special Executive Session Board Meeting. The purpose of the meeting will be primarily to discuss and approve board business and agenda items previously scheduled on April 25, 2016 but cancelled due to lack of quorum, as per the agenda available on the District’s website (<http://narlington.k12.nj.us/Files/District/Meetings/april%2025%202016%20agenda.pdf>), which includes, but is not limited to, the employment of personnel, approval of leaves of absence, recognition of personnel, affirming Harassment, Intimidation and Bullying investigations, approving agreements for the summer school program, authorizing school facility use, approving the submission of the final 2016-2017 budget, approval of travel expenses, approval

of various finance items (budget transfers, board secretary's report, treasurer of school monies' report, and payment of bills), approval of tuition contracts, and the awarding of contracts following public bid openings. The North Arlington Board of Education website will post the full agenda for the May 2, 2016 meeting in advance of the meeting. The meeting will take place in the Board Office, 222 Ridge Road, No. Arlington, NJ.
