A. MOTION TO APPROVE THE ACCEPTANCE OF THE BID FOR RENOVATIONS AND ALTERATIONS ON THE FORMER QUEEN OF PEACE HIGH SCHOOL

WHEREAS, the North Arlington Board of Education (“the Board”) advertised for bids for the Renovations and Alterations Project at the recently purchased Queen of Peace High School (“Project”); and

WHEREAS, on October 29, 2019, the Board received bids for the Project; and

WHEREAS, the lowest bidder, Billy Contracting and Restoration, Inc. (“Billy Contracting”), submitted a base bid in the amount of \$2,083,000, together with Alternate No. 1 in the amount of \$58,000, for a total contract sum of \$2,141,000; and

WHEREAS, the bid submitted by Billy Contracting is responsive in all material respects and it is the Board’s desire to award the contract for the Project to Billy Contracting.

BE IT RESOLVED, that the Board awards the contract for the Project to Billy Contracting in a total contract sum of \$2,141,000.

BE IT FURTHER RESOLVED, that the Board Attorney is hereby directed to draft the agreement with the successful bidder consistent with this Resolution and with the terms contained in the bid documents approved by the Board for the Project. The Board President and the Board Secretary are hereby authorized to execute such agreement and any other documents necessary to effectuate the terms of this Resolution.
