### A Team Approach for Learning

Dear Parent,

Century Elementary School's Title 1 program is classified as "Schoolwide". This means that any student can receive Title 1 assistance from a certified teacher or para whenever the classroom teacher assesses that such a service would be beneficial to the student's academic growth and achievement. Your child may never require Title 1 services this year. Your child may benefit from Title 1 services for a short period of time or the entire school year, dependent upon how he/she progresses. Teachers are continually monitoring and assessing student progress. It is our goal to assist students in reaching a high bar of success.

#### Century School **parents' responsibility** in this compact:

We will support our child's academic progress by

- Checking backpacks daily for classroom informational sheets/homework assignments.
- Monitoring homework completion (signing when needed) and assuring adequate rest / nutrition / attendance.
- Informing appropriate school personnel of any health / academic concerns our child may have.
- Assisting our child in wise decision making regarding his/her extra-curricular and outside school activities.
- Supporting our child through attendance at conferences and classroom events as well as assisting with academics and offering volunteer services when possible.

#### Century School **students' responsibility** in this compact:

- Read outside of the school setting to increase vocabulary, fluency, comprehension, and knowledge.
- Complete assignments and ask for help when it is needed. Persevere even when it is difficult.
- Learn basic facts to increase math comprehension.
- Show parents/guardian any school/classroom written communication given.
- Come to school rested and prepared for class each day.

#### Century School's **responsibility** in this compact:

- In-service for faculty will be provided during staff development concerning our role in, and the importance of, encouraging parent involvement.
- The annual Title 1 meeting will be held in the fall in conjunction with the Century School Open House.
- The Parent & Family Engagement Policy will be evaluated in an attempt to gain more parental contact time with children pertaining to school activities.
- A parent survey will be sent for feedback about school improvement and classroom programming.
- Family Involvement events will be evaluated to determine the impact that the activity has upon student learning.
- The Title 1 Compact will be evaluated with the goal of assuring that each stakeholder's responsibilities remain relevant.

#### Century School **teachers' responsibility** in this compact:

We will clearly express to parents the classrooms' academic expectations, grading procedures, and opportunities for involvement in your child's education via the following:
