June 13, 2023 at 6:30 PM Regular Meeting – Study Session MINUTES

The regular meeting of the School Board of Independent School District No. 283 of St. Louis Park, Hennepin County, Minnesota, convened at 6:39 p.m. on Tuesday, June 13, 2023 in St. Louis Park City Hall – Council Chambers. Present: Abdihakim Ibrahim, Colin Cox, Heather Wilsey, Anne Casey, Virginia Mancini, Sarah Davis, and Superintendent Asti Osei. Director Ken Morrison was absent.

CALL TO ORDER

Chair Anne Casey called the special session meeting to order at 6:39 p.m. in the St. Louis Park City Hall – Council Chambers and by the use of District Teleconferencing.

LAND ACKNOWLEDGEMENT

Board Vice-Chair Cox recited the Land Acknowledgement “We are gathered on the land of the Dakota and Ojibwe peoples. I ask you to join me in acknowledging the Dakota and Ojibwe community, their elders both past and present, as well as future generations. St. Louis Park Public Schools also acknowledges that it was founded upon exclusions and erasures of many Indigenous Peoples, including those on whose land this school district is located. This acknowledgement demonstrates a commitment to dismantling the ongoing legacies of colonial power and the district’s desire to support the ongoing work of local Indigenous communities to thrive in our schools.”
