
# Federal Philosophy


Family is responsible to pay for student's education

# Types of Financial Aid







\*\*Financial Aid is any money given, paid or loaned to help pay for education.\*\*



# Federal Work Study

- Campus-based aid
- Must be earned through work
  - Current availability varies
  - Job may be on or off campus
- Undergraduate and graduate students
- May have annual maximum
  - Funding levels vary at each institution
- Need-based

## Federal Loans


**Subsidized- Need based.** Interest is paid by the federal government while you are in school. Repayment starts six months after you graduate or drop below half-time.

**Unsubsidized- Not need based.** You pay the interest or add it to the principal balance and begins to accrue at the time you receive 1st check. Repayment starts six months after you graduate or drop below half-time.


**PLUS -** Unsubsidized loan for parents of undergrads. Can borrow up to the COA – any financial aid. Fixed and begins to accrue at the time funds are released.

\*Interest rates may vary year to year and are set by Congress.


## Types of Financial Aid: State Aid

# **Enrollment Fee Grant**

Our commitment to you expanded – FREE tuition for all within our service area. There are four criteria for 'FREE COLLEGE'

- Live in WVMCCD service area.
- Apply for financial aid through the 2023-24 <u>Free Application for</u> <u>Federal Student Aid (FAFSA)</u> or <u>California Dream Act</u> <u>Application</u> and list either Mission College or West Valley on your application.
  - Not need based
- Be a California resident or eligible for CA residency via AB 540.
- Intend to earn a degree or credit-level certificate at one of our colleges.

# Ex: WVC Community Grant

### **Requirements:**

- Class of 2024 Graduate from CA high school or equivalent
- 2024-2025 FAFSA or CA Dream Act
- Complete an Orientation & Educational Plan
- •Enroll & complete 12 WVC units each semester

**Benefits:** 

•\$1,000/semester (up to \$2,000/year) OR

•\$400/semester if receiving the Enrollment Fee Grant

•Note: this grant is <u>NOT</u> need-based





### Understanding the FAFSA® Form

#### <sup>2 of 4</sup> Contributors to the FAFSA<sup>®</sup> Form



#### Service Services Parents or Spouses

Your answers on the FAFSA form will determine if any contributors need to be identified. These contributors will complete their own sections of the form and are asked to provide personal and financial information, but will not become financially responsible for your education.



#### + How to Invite

Contributors will need to log in with their own FSA ID to provide their information. To invite a contributor to your FAFSA form, you'll need to provide their name, date of birth, Social Security number, and email address.

#### Information or Documents You May Need 🔥

You might need the following information or documents as you fill out the FAFSA form:

- Tax returns
- Records of child support received
- Current balances of cash, savings, and checking accounts
- Net worth of investments, businesses, and farms


## A contributor IS...

Anyone who is required to provide information on a student's FAFSA form, including the student, the student's spouse, a biological or adoptive parent, or the parent's spouse (stepparent).




## A contributor ISN'T...

Non-adoptive grandparents, foster parents, legal guardians, brothers c sisters, and aunts or uncles, even if helped provide for or raise the stud

### **Changes to calculation process**

- Dependent students with divorced or separated parents will include information on their FAFSA form only for the parent that provides the greater portion of the student's financial support.
- "Family Size" replaces the term "Household Size" and aligns with the number of individuals reported on the federal tax return.
- Child support received will now count as an asset.
- Family farms and small businesses will now count as assets, less the family's primary residence if it is also located on the farm.







  - EX: Your program requires 60 units for an AA/AS, but some classes have prerequisite classes, therefore you must complete the program under 90 units.
