Important Notice: Per the directive of Board President Russell Johnson, the regular meeting of the Athens City Board of Education will be at 6:30 PM on May 7, 2020, at the Athens City Schools' Central office located at Highway 31 North, and it will be conducted pursuant to Section 3 of Governor Kay Ivey's March 18, 2020 Proclamation concerning the operation of the Open Meetings Law during the state of emergency related to COVID-19. As such, all deliberations conducted, and actions taken, during the meeting will be limited to matters within the Athens City Board of Education's statutory authority that are (a) necessary to respond to COVID-19, or (b) necessary to perform essential minimum functions of the board of education. As such, some members of the board of education may physically attend the meeting at the Athens City Schools' Central Office, and other members of the board may participate in this meeting by means of electronic communications. Additionally, **the meeting will not be open to physical presence by members of the general public.** However, no less than twelve (12) hours after the meeting, the school board will post a summary of the meeting on its website at: <https://www.acs-k12.org/Page/1309>. The summary will recount the deliberations conducted and the actions taken by the board with reasonable specificity to allow the public to understand what happened.
