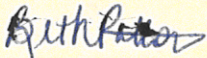

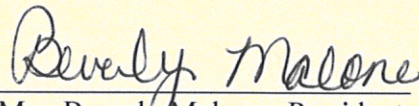
7. Ms. Anne Burrows, School Board Attorney, made the recommendation that the Board enter into an executive session.
