- 5. Mr. Lee Edminson, Facilities Manager for ACS gave an update on current projects within the system:

James Cowart - Roof

We are starting to receive materials, several truckloads of insulation arrived Still plan to start mid to late September

Clinton Street - Gym HVAC

A concrete pad is poured and ready to accept the HVAC unit The HVAC unit will be set up in the next couple of weeks Ductwork inside the gym started this evening Scheduling with AU Gas to set meter Scheduled with AU Elect for power - 4-5weeks out

Rec Center - Weight Room HVAC

Working through the contracts & submittal process The Central Unit is 30 weeks out

Stadium - Bleacher Coating

The punch list is complete

Working on some warranty items; 6 areas were identified that had water coming through

Stadium - Track

Milling of old asphalt track completed yesterday

The track was proof rolled - found one long area under the o/s lane that did not meet compaction. We are leaving exposed in hopes that it will tighten up and minimal remediation will be needed Start base next week and paving to follow

Athens Elementary - New Building

Our windows have arrived

Site work is ongoing and is taking shape, including curbs, roads, etc.

We are meeting with the city engineer / civil engineer Wednesday to discuss the existing curb vs. new Completed our first above ceiling inspection on Tuesday - partial A wing next one will be Sept 6th Furniture is on schedule for a mid-Oct delivery

Looking at early / mid-Oct completing the project

Athens High - Auditorium

Serena and I are working through the numbers...the first round of budget numbers came in well above our budget

Athens High - Gas Leak

Gas was turned off to the building Tuesday around lunch

The contractor started breaking down the pipes and isolating sections so a pressure test could be performed and make any repairs needed

As of this evening, ALL areas have been tested w/ air in sections; for example, the 7psi gas line was tested with 50psi of air, 2-5psi gas line was tested at 10psi - 20psi with air respectively

Air test will be put on the entire system this evening and will be inspected by ACS, Contractor, and Gas Dept in the morning...

Once confirmed the pressure test is held the contractor will start re-installing the regulators...around mid-morning contractor/gas dept we will turn the gas back on and purge the air out of the system Another check will be done early afternoon...we will walk the building with Gas Dept with their detectors...

We will again walk the building over the weekend and be there early Monday morning to ensure the gas is not present in the building...
