10. Upon conclusion of the executive session Mrs. Malone moved that the board return to regular session. Mr. Henry seconded the motion. The vote was unanimous.



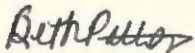

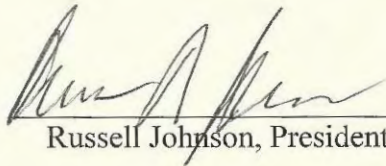
11. Mrs. Manville moved that the board approve the recommendation from Mr. Johnson. Mr. Henry seconded the motion. The vote was unanimous.
