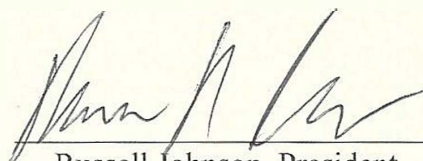
16. Upon conclusion of the executive session, Mrs. Malone moved that the board return to regular session. Mrs. Manville seconded the motion. The vote was unanimous.
