

Lub niam tswv yim ntawm daim Ceeb Toom no qhia rau niamtxiv/tus saib xyuas thiab menyuum lawv cov cai hauv Tshooj 504 of the Rehabilitation Act of 1973. Tshooj 504 yog ib txoj cai pej xeeb uas txwv tsis pub muaj kev ntsub ntxaug li kev ua tsis taus tus kheej. Minneapolis Public Schools muaj rau koj, li niamtxiv los tus saib xyuas ntawm ib tus menyuum, nrog cov txheej txheem cai nram no:

1. Koj muaj cai los txais ib daim ntawv luag Ceeb Toom thaum lub district taw qhia, ntsuam xyuas, tsis kam ntsuam xyuas, muaj tso rau kev kawm tshiab, tsis tso rau kev kawm tshiab los pauv ntau yam huav kev kawm ntawm koj tus menyuum vim koj tus menyuum qhov kev pab tsis taus tus kheej.
2. Koj muaj txoj cai rau ib qhov kev ntsuam xyuas ntawm koj tus menyuum yog lub district muaj pov thawj tias koj tus menyuum hlwb qeeb thiab lub cev tsis taus uas ua tsis tau tej yam haujlwm tseem ceeb hauv lub neej. Koj yeej muaj txoj cai ua ntej tej yam kev npaj rau kev txhawb pab cuam thiah ua ntej kev pauv hauv kev kawm (piv li, qhov hais kom muab tshem tawm).
3. Koj tus menyuum muaj cai rau txoj kev kawm ntawv dawb. Koj muaj feem los them tib tus nqi li niamtxiv/tus saib xyuas rau cov menyuum uas muaj qhov ua tsis taus (piv li, tus nqi kev mus ncig los tus nqi ua phau ntawm ploj).
4. Txog rau qhov tshaj plaws uas tsim nyog, koj tus menyuum muaj cai kawm ntawv nrog rau cov yeej tseem ua taus.
5. Koj muaj cai los tshawb xyuas txhua yam ntaub ntawv lub tsev kawm ntawv khaws txog koj tus menyuum.
6. Koj muaj cai los mus sib hais raws kev txiav txim ncaj ncees yog koj xav tias tej qho ua tau tsis yog txog rau koj tus menyuum kev qhia tawm, kev ntsuam xyuas los yog kev kawm li hauv Tshooj 504. Koj muaj cai tuaj koom kiag nyob rau qhov kev txiav txim ncaj ncees thiab sawv cev los ntawm ib tus kws lij choj, yog koj xav ntiav ib tus.
7. Yog koj xav tawm tsam hais ib qho kev txiav txim los ntawm pawg Tshooj 504 li qhov hauv rooj sib hais ncaj ncees, koj yuav tsum tau xyuam ib daim ntawv Notice of Appeal los yog Request for Hearing rau lub District Section 504 Coordinator ntawm:

Koj muaj cai los tawm tsam qhov kev txiav txim li kev qhia tawm, ntsuam xyuas, rov qab ntsuam los yog kev kawm los hauv koj tus menyuum qhov 504 Plan raws lub District's Grievance Procedure, luam tau ib daim los hauv District's Section 504 qhov vamsab los yog thov tuaj rau tus District Section 504 Coordinator. Koj yeej qhia tau lwm yam kev tsis txaus siab los yog kev xav kom sib hais rau tus District 504 Coordinator, los tau.
9. Koj muaj cai sau ib daim ntawv tsis txaus siab nrog rau lub Office for Civil Rights (OCR) of the U.S. Department of Education.
