

## Minneapolis Public Schools Minnesota Parent Right-to-Know Act

**Txog:** Niamtxiv, Tus Saib Xyuas, & Cov Neeg Ua Haujlwm

Nyob rau xyoo 2000, Minnesota ib tsab cai tau tsim los kom tsev kawm ntawv qhia rau niamtxiv, tus saib xyuas thiab cov neeg ua haujlwm hauv tsev kawm ntawv txog cov tshuaj tua kab uas tau cov los ywg tua raws cov cheeb tsam tsev kawm ntawv. Lub xeev tau kom qhia rau koj tias yuav muaj kev raug rau menyuum kev noj qab haus huv yav ntev tom ntej no li thaum tau tua cov tshuaj los yog hom tshuaj uas muaj nyob rau hauv los yeej tseem tsis totaub tau zoo.

Tshaj no, txoj cai tau kom tsev kawm ntawv tua cov tshuaj raws li cov sijhawm npaj los tuaj thiab muab cov sijhawm tseg kom cov niamtxiv tus saib xyuas tau paub tau pom los yog muaj nyob rau hauv lub tsev kawm ntawv. Daim Safety Data Sheets yuav tsum muab tau thaum nug txog cov khoom siv hais los no.

Minneapolis Public Schools siv cov neeg paub, muaj ntaub ntawv tso cai txog kev tiv thiab thiab lom nas tua kab los yog lwm yam kab hauv ib cheeb cov tsev kawm ntawv. Peb kev tswj pab tua thiab lom cov hais los no yog siv qho hauv kev los khoo tua tshuaj kom txhob muaj ntau li thaum uas ho yuav ua txog rau qhov ho muaj kev tshwm sim tsis zoo rau neeg, vaj tsev thiab ib cheeb tsam. Peb cov kev npaj ua yog siv cov hauv kev los ua ua ke xwb li:

1. ntsuam/saib xyuas kom tseeb saib puas muaj tej kab ntawm, thiab puas yuav siv kev tua tshuaj;
2. muab kev tu kom zoo/huv si kom txhob muaj kab los yog nas thiaj tsis tau siv kev tua tshuaj;
3. kev tsis txhob siv tshuaj tua ib yam li caws ntxiab, caw kua nplaum thiab kev ntsuam; thiab
4. siv cov EPA-registered pesticide chemicals **li uas qhov yuav tsum tau siv xwb.**

Qhov Pesticide/Herbicide Application Schedule muab tau rau koj los tom tsev kawm ntawv chaw ua haujlwm. Yog xav kom lawv xa ntawv tuaj qhia koj qhov caij tua kab li cov hnuv tsis hais li cov tau sau tseg lawm (tsis muaj cov uas ti tes ti taw tuaj tua), sau daim form hauv qab no xa tuaj. **Yog tsis xav kom peb qhia koj, tsis txhob sau thiab xa daim form no tuaj.** Yog koj muaj lus nug txog tsab ntawv ceeb toom no, thov hu MPS Environmental Health & Safety ntawm 612-668-0310.
