2. Implements the goals on the Individual Family Services Plan (IFSP) in the natural environment (home) or school.
3. Writes goals and objectives for IFSP/IEP.
4. Provides service coordination for the IFSP.
5. Monitors progress on the IFSP and provides reports to parents.
6. Attends IFSP/IEP meetings.
7. Attends staff development activities.
8. Maintains accurate and complete records pertaining to children and family services.
9. Coordinates information gathering for children, families, and the IFSP process.
10. Such alternatives to the above qualifications as the Calvert County Public Schools may find appropriate and acceptable.

References must be directly related to education experience and must include immediate supervisor.

Prior to the filling of any vacancy, permanent employees who have requested a transfer in a timely manner shall be afforded an opportunity meet with the supervisor of the position for which the vacancy exists.

State law requires that anyone hired after October 1, 1986, who will have contact with school children, must be fingerprinted and submit to a criminal background investigation. Federal law requires that a new employee must complete the Employment Eligibility Verification (Form I-9) in person before beginning employment. Employment is conditional upon successful completion of a drug screen. Current employees of the Calvert County Public Schools are exempt from these requirements.

House Bill 486 – Child Sexual Abuse and Sexual Misconduct Prevention Statement

Pursuant to Section 6-113.2 of the Education Article, Annotated Code of Maryland - House Bill 486 - Child Sexual Abuse and Sexual Misconduct Prevention, all applicants are required to report all former employment where direct contact with minors may have occurred.
