

## 2024-25 FINANCIAL AID

How to Apply for Financial Aid

- All families applying for financial aid must complete the Parents' Financial Statement (PFS)
  form that is part of the financial need assessment provided by School and Student Services
  (SSS), an independent evaluation service used by many independent schools.
  This form and instructions for completion may be accessed at sssandtadsfa.force.com/familyportal
  and should be submitted using Charlotte Christian's school code, 2318.
- In order to meet the Charlotte Christian deadlines for financial aid priority consideration, the PFS form must be completed on the School and Student Services portal.
   In addition to the PFS form, the following documents should be uploaded to the SSS website.
  - 2022 federal income tax return and the 2023 federal income tax return when available.
  - W-2 Form for 2023.
  - Business tax return if you own all or part of a business.

- 4. Financial aid awards for returning families who have completed the process and submitted all required documents will be provided as files are completed. Awards for new families will not be provided until their students have been accepted to Charlotte Christian School.
- 5. Families appying for financial assistance to Charlotte Christian School must also apply to the North Carolina Opportunity Scholarship Program. Applications for this program open on February 1 and can be accessed at <a href="http://www.ncseaa.edu/k12/">http://www.ncseaa.edu/k12/</a>.

All tuition assistance grants are based on financial need. In order to provide assistance to as many families as possible, the maximum financial aid award from the Tuition Assistance program is limited to 50 percent of tuition. Families are responsible for all other school fees including, but not limited to, installment and tuition protection plan fees and other school related costs. Applications for financial assistance will be considered as applications are completed, but awards will be limited by the funding available at the time of completion.

# **Financial Aid Due Dates**

#### **Current Charlotte Christian Families**

- **February 5, 2024** Parents completing the School and Student Services (SSS) financial assistance package by this date will receive priority consideration for financial aid awards.
- After February 5, 2024 Returning parents may still complete the financial assistance application, but awards will be limited to funds available at each grade level. Financial aid awards will be communicated after receipt and review of the completed SSS evaluation.

## **New JK and K Applicant Families**

- **February 5, 2024** Families completing the School and Student Services (SSS) financial assistance package by this date will receive financial aid award notification by February 29, 2024.
- After February 5, 2024 Families of JK and K applicants may still complete the financial
  assistance application, but awards may be limited to funds available at each grade level.
   Financial aid awards will be communicated after receipt and review of the completed evaluation.

### **New Grades 1-12 Applicant Families**

- March 1, 2024 Families completing the School and Student Services (SSS) financial assistance package by this date will receive financial aid award notification by March 29, 2024.
- After March 1, 2024 Families of grades 1-12 applicants may still complete the financial
  assistance application, but awards will be limited to funds available at each grade level.
   Financial aid awards will be communicated after receipt and review of the completed evaluation.

**In addition to the PFS form,** the following documents must be uploaded to the SSS website in order to complete your application for assistance.

- 2023 federal income tax return OR
- If your 2023 return has not been completed, submit the 2022 tax return AND your 2023 W-2 form(s)
- Business tax return for the most recent year if you own all or part of a business
