ISSDA Speech and Debate – New Coach of the Year Award Dr. Mark Daniel, superintendent, presented the following information and recommendations concerning awards and recognitions:

RECOMMENDATION: It was recommended that the Board recognize Snider High School's Speech and Debate Coach Mark Tojo for being the recipient of the Indiana Schools Speech and Debate Association (ISSDA) New Coach of the Year Award for 2023.

RELATED INFORMATION: The ISSDA New Coach of the Year Award is given to an Indiana coach who has completed 1-5 years of experience coaching speech and debate. Veteran coaches nominate new coaches who have made an impact on speech and debate in their area. The award includes a certificate and a \$500 check to be used to improve the opportunities for the school's speech and debate program.

This Coach's methods have yielded positive results, as he coached his first sectional championship and led his school's team to its strongest sectional finish in 11 years. Mark Tojo was also voted to the Northeast Indiana District committee in 2023.

Mark Tojo, Snider Teacher and Speech & Debate Coach was congratulated for his excellence and dedication in education and coaching. Also in attendance was Chad Hissong, Snider Principal and Linda Alt, President of the Indiana Schools Speech and Debate Association.

Title I, Part A-Basic and Neglected Grant Dr. Daniel presented the following recommendation concerning the Title I, Part A-Basic and Neglected Grant:

RECOMMENDATION: It was recommended that the Board approve the acceptance of the Title I, Part A Basic and Neglected Grant for 2023-2024 from the Indiana Department of Education in the amount of \$14,743,234.54.

RELATED INFORMATION: Title I is a federally funded program designed to enable schools with high concentrations of low-income students to provide opportunities for children to acquire the knowledge and skills in the state content areas and to meet and/or exceed the state performance standards for all children.

A school building's eligibility for Title I services is primarily based on criteria related to family income. FWCS determines target areas based on numbers of students receiving free or reduced lunch and/or direct-certified government benefits. In 2023-2024, Title I services are supporting all thirty-three elementary schools: Abbett, Adams, Arlington, Bloomingdale, Brentwood, Bunche, Croninger, Fairfield, Forest Park, Franke Park, Glenwood Park, Haley, Harris, Harrison Hill, Holland, Indian Village, Irwin, Lincoln, Lindley, Maplewood, Northcrest, Price, Scott, Shambaugh, South Wayne, St. Joseph Central, Study, Towles, Washington, Washington Center, Waynedale, Weisser Park, and Whitney Young. Additionally, these locations have Title I-funded therapeutic counselors to support student needs.

Title I funding also provides for nationally-accredited Pre-K programs in the following 23 locations: Abbett, Adams, Arlington, Bloomingdale, Brentwood, Fairfield, Forest Park, Franke Park, Haley, Harris, Harrison Hill, Holland, Indian Village, Lindley, Maplewood, Northcrest, South Wayne, Scott, Study, St. Joseph Central, Washington, Washington Center and Waynedale serving just over 700 students and their families.

Students who receive free or reduced lunch and live in FWCS Title I school attendance areas but attend non-public schools are provided supplemental instruction through a resource teacher/tutor, an instructional assistant or a service provider. Title I-eligible students from thirty non-public schools receive services funded from the 2023-2024 Title I grant. Additionally, FWCS students who are experiencing homelessness and students who reside at Crossroad Children's Home, an institution for neglected children, receive supplemental educational services through Title I.

The grant is managed by Kimberly Brooks, Title I Director, who was available to answer questions.

North Transportation Center Underground Fuel Storage Tanks Dr. Daniel presented the following recommendation concerning the North Transportation Center Underground Fuel Storage Tanks:

RECOMMENDATION: It was recommended that the Board approve a contract with Blue Energy Equipment for the purchase of underground fuel storage tanks for the North Transportation Center in the amount of \$160,414.

RELATED INFORMATION: This purchase will provide one 25,000 gallon underground fuel storage tank for diesel fuel and one 6,000 gallon underground fuel storage tank for unleaded gasoline fuel for the North Transportation Center. The tanks are being pre-purchased now to ensure delivery due to the long lead time for the purchase of equipment. The remainder of the project, including removal of existing tanks, installation of new tanks and additional parts, is expected to be recommended at the November 13 Board meeting.

A motion was made by Anne Duff, seconded by Rohli Booker, that the recommendation concerning the North Transportation Center Underground Fuel Storage Tanks be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Daniel presented the following recommendation concerning the Public Meeting to Discuss the Collective Bargaining Agreement Between the Fort Wayne Education Association (FWEA) and FWCS:

RECOMMENDATION: It was recommended that the Board conduct a public meeting to discuss the tentative collective bargaining agreement between FWCS and the FWEA.

RELATED INFORMATION: I.C. 20-29-6-19 requires that this Board hold at least one public meeting "to discuss a tentative collective bargaining agreement" prior to ratification. FWCS properly noticed this public meeting and posted the tentative agreement between FWCS and the FWEA on the public website as required by Indiana law.

Earlier this year, teams from FWCS and the FWEA informally bargained the renewal of their contract and came to a tentative agreement. The most significant details are as follows:

- The salary range for all teachers will be \$46,627.00 to \$78,690.00 in the 2023-24 school year and \$47,093.00 to \$79,156.00 in the 2024-25 school year.
- The parties elected to maintain a salary schedule, which will increase by 3% in 2023-24 and 1% in 2024-25, with smaller step increases for entry-level teachers, which enabled FWCS to start those teachers at higher salaries. As teachers progress on the schedule (based on evaluation and education), their pay will increase between 5.8% and 9.9% over two years.
- FWCS will continue to compensate teachers for classroom coverage to help manage a substitute teacher shortage, and modifications to the program to improve efficiency.
- FWCS agreed to allow teachers to use two days of personal illness leave for personal business and to expand teachers' eligibility to access the sick leave bank.
- FWCS will phase out the "Buy-Up" health insurance plan at the end of the 2024 calendar year.
- FWCS agreed to increased pay for event workers at varsity football games.
- FWCS will add boys' volleyball and girls' wrestling coaches and assistant coaches at the high school level, as well as robotics coaches for schools with those teams. FWCS will also increase compensation for high school cheerleader coaches and show choir directors, and create a social media and website position related to the expansion of those responsibilities.

The Board will meet on October 23, 2023 to ratify the Contract. As required by law, Public Comment will be taken at that meeting. Rose Costello, Executive Director of Human Resources, was available to answer questions.

The public meeting was opened at 6:34 p.m. Board members comments and questions were answered. The public meeting was closed at 6:42 p.m.

Dr. Daniel presented the following recommendation concerning the Public Hearing on the 2024 Budgets, Capital Projects Plan and the School Bus Replacement Plan:

A public budget presentation was made at the September 11, 2023, Board of School Trustees meeting. All Board adopted funds and proposed budgets were discussed, and estimated tax rates were reviewed. The notice for the Capital Projects Plan and the Bus Replacement Plan were properly advertised on September 11, 2023 on Indiana Gateway and the FWCS website.

President Norman has been fortunate to recently attend state and national school board associations conferences to talk about the work FWCS does everyday and the number of lives we touch. She is a proud to be a FWCS school board member, parent and graduate. Ms. Norman spent Principal for a Day at Memorial Park, where she got to experience Pirate Time, along with seeing collaboration. She enjoyed seeing students talking, being encouraged, working in teams. She also got to see Naviance closer and experience middle school lunch. Maria thanked the Culinary Arts students for an amazing lunch.
