

Georgia Schools Tax Credit Program

Your participation in the Georgia Education Expense Credit Program gives more children a chance to receive a Howard School education. Participants can opt-in each taxable calendar year and, through a third-party facilitator, redirect a portion of their state income tax dollars to The Howard School.
