Chair Killens called the Regular Board Meeting to order at 6:30. Trinity Monahan entered a motion to approve the agenda as presented. Bill Amos seconded; the motion to approve the agenda carried unanimously with all members in attendance.

CONSENT AGENDA

NEW BUSINESS

• Brooke Oliver, SHHS Public Relations Representative, updated members about the things going on at the high school. She reported that there was a College Application Week that included activities around college applications and several college representatives visited campus. - Chair Killens reviewed the policy updates recommended by OSBA. The policies being reviewed included:

 - GCBDF/GDBDF Paid Family Medical Leave Insurance

The policies were introduced prior to the meeting on October 25th, and the updates posted on the district website. This was the second reading, and there were no comments or questions from members.

- Jessica Seay reported that <u>RESOLUTION 2023-24 #7</u> would serve to grant the district an exemption for competitive bidding, pursuant to ORS 279B.075(2). This matter is being brought to the Board, serving as the Local Contract Review Board (LCRB), so that a boiler and condensate neutralizer can be purchased from particular manufacturer so that they are compatible with other boiler components being used on the HS campus. This need is not related to the current bond program.
